#### **CAR MOTIONS**

#### WORLD MOTIONS:

# Motion 1: To replace the existing stories in the Fifth Edition Basic Text *Narcotics Anonymous* with those contained in Addendum B.

Intent: To create a Sixth Edition Basic Text with stories that are more current and that better represents our global fellowship.

Financial Impact: The cost of creating this material has already been incurred. The only additional costs to NAWS that will be incurred by adopting this motion are initial production costs for the book, which would be minimal.

Note that only if this motion is adopted, would the following motions related to creating a Sixth Edition Basic Text be offered.

# Motion 2: To approve the remaining revisions to the Fifth Edition Basic Text.

Narcotics Anonymous, as represented in Addendum B. This includes , the Preface to the Sixth Edition,

the titles "Our Program" and "Our Members Share," which would replace the titles "Book One" and "Book Two" respectively, \*>>> the Introduction to Our Members Share, - the abstracts, ? the reflections, and

? the titles and descriptions for the sections "Beginnings," "Coming

**Home," "Regardless of...," and "Life on Life's Terms."** Intent: To include the remainder of the material contained in Addendum B in the Sixth Edition Basic Text; this includes the removal of the titles "Book One" and "Book Two."

Financial Impact: The cost of creating this material has already been incurred. The only additional costs to NAWS that will be incurred by adopting this motion are initial production costs for the book, which would be minimal.

# Motion 3: To allow the World Board to approve updates to the statistical

information (the numbers of meetings, countries, and so on) in the Preface to

the Sixth Edition Basic Text *Narcotics Anonymous* regularly with an "as of date in the footnote.

Intent: To allow statistical representation of the fellowship in the Basic Text to be Keep current Financial Impact: The statistical information in the Preface will be changed only when we are ready for a new printing of the Basic Text (and it may not be changed with every new printing, depending on how often these occur). These figures are already routinely updated for each *NAWS Annual Report*, so revising them is a simple matter that will cost us nothing extra except the labor to revise this paragraph. Policy Affected: None.

Motion 4: To approve the removal of the specific source citations in *Just for Today* for versions of literature no longer in print and to include, at the beginning of the book, an explanation that quotes without a citation are from previous versions of NA literature. Also to approve the use of a footnote in the foreword to *Just for Today* to update the reference to the Fifth Edition of the Basic Text.

Intent: To not require a new edition of *Just for Today* each time existing literature is updated, changed, or replaced

Financial Impact: We are keeping our inventory of *Just for Today* low pending conference decision about the Sixth Edition Basic Text. The financial impact of any changes to the book would therefore be minimal.

# Motion 5: To approve the inclusion of an updated and revised index in the

#### Sixth Edition of the Basic Text, Narcotics Anonymous.

Intent: To create a more useable index for the text.

Financial Impact: By the time this motion is decided, our expense associated with

creating the proposed index for the Sixth Edition Basic Text will already have been incurred. The price for indexing, as well as creating the electronic file for use with future translated versions, is less than \$3,000.00. Policy Affected None.

Motion 6: To approve two specific copyedits to the Basic Text *Narcotics Anonymous:* First, to replace the name "N A" (with periods after the two capital letters) with "NA" (with no periods). Second, to remove the footnote in Tradition Eleven that mentions *A Guide to Public Information Newly Revised.* Intent: To make our Basic Text more consistent with other NA fellowship-approved recovery literature.

# Motion 7: To replace the existing IP #13, Youth and Recovery, with the revised draft contained in Addendum C and change the title of this IP to By Young Addicts, For Young Addicts,

Intent To replace the existing informational pamphlet with a more current reflection of our experience.

Financial Impact- The cost of creating this material has already been incurred. The only additional costs that will be incurred by adopting this motion are initial production costs, which would be minimal.

Policy Affected: This motion would replace the existing IP #13. (See Addendum D.)

Motion 8: To approve the draft of For the Parents or Guardians of Young People in NA contained in Addendum E as IP#27. Intent- To have an informational pamphlet that helps explain Narcotics Anonymous to the parents and guardians of young recovering addicts. Financial Impact: The cost of creating this material has already been incurred. The only additional costs that will be incurred by adopting this motion are initial production costs, which would be minimal.

# Motion 9: To add English Roman Numeral Medallions In Bronze to NAWS inventory as a specialty item and direct the World Board to price them accordingly.

Intent: To add this item back to NAWS inventory in English only for those who prefer them over the standard Arabic numeral medallions and sell them as a specialty item.

Maker: Tri-State Region

Financial Impact: The direct cost to create another set of dies would be approximately \$13.000 We are not able to estimate other associated costs of keeping these items in our inventory at this time.

Policy Affected: None.

Motion 10: To direct the World Board to add to NAWS inventory Roman numeral medallions in ail current finishes and languages produced by NAWS. Whether these medallions are an addition to inventory or a replacement for the current Arabic numbered medallions is left to NAWS discretion.

Intent: To reinstate Roman numeral medallions in NAWS inventory Maker: Region of the Virginians

Financial Impact: The direct cost to create the dies for all languages would be approximately \$42,000. With the proposed changes to our medallion design and finishes pending, if is not possible to estimate the cost of turnover of our inventory or of keeping these items in inventory on an ongoing basis. Policy Affected: None.

# Motion 11: To direct the World Board to provide financial support to the Northern New Jersey Region in the amount of \$36,000.

Intent: To have MAWS assist with a portion of legal expenses incurred by the

Northern New Jersey Region.

Maker: Northern New Jersey Region

Financial Impact: The immediate financial impact would be \$36,000, but it is

impossible to estimate the potential costs over time as the case would

potentially set a precedent for any future such lawsuits

Policy Affected: None

# Motion 12: To require that all NA Service pamphlets intended for group and individual use be included in the Conference *Agenda Report for* approval.

Intent: To give the approval of service related pamphlets intended for group and individual use to the World Service Conference. Maker: New Jersey Region

Financial Impact: We are not able to calculate the financial impact of this motion because there are too many variables. The direct cost would be the loss of whatever inventory we have on hand. To change the process of approval could affect the cost of future projects, but we cannot estimate that at this time. Policy Affected: The policy affected would amend the portion of the WB Guidelines that calls out service related information pamphlets as well as the new notation in the Approval Process for Service Material.

William E. came down from Region and helped us conduct a Group Booklet Workshop. We all got there around 11:00 am. We all got there around 11:00 a.m. and fellowshipped for a while. We had chili, hot dogs, and drinks before we got down to business. I think everyone enjoyed the chance to get to know William even though several of us had the pleasure of meeting him before.

After having a good meal and fellowship, we got down to the work at hand. William guided us through the Group Booklet and answered our many questions in a loving N.A. way. We discussed how to deal with that come to our meetings and identify themselves as addicts and alcoholics and talk about being clean and sober. Hello Family,

I'd like to take this moment to thank everyone in our Region for allowing to me be of service, it is truly a joy to be able to give back to our beautiful Fellowship what has been so freely given to me. The Outreach Subcommittee was very excited to be asked to facilitate two Learning Days/ Workshops for two Areas last month.

The first Learning Day held in Jackson for the Mid-West Area was on the Group Booklet I was able to leave the night before and check into a Motel room. Two addicts came by and picked me up, we went to a meeting. Afterwards we had supper and I went back to the motel. An addict came by early the next morning and took me to the place reserved for the workshop.

We arrived twenty minutes before the workshop was to begin. In the next thirty minutes, addicts began to arrive, and bought chili, hot dogs and all the fixings. What a beautiful way to start the day. There were 18 in attendance. We started an hour later than what was scheduled. Nobody seemed to mind because we were having such a wonderful time.

The Outreach Subcommittee would like to thank the whole Volunteer Region for approving the budget for last year. Because of this we were able to provide the Literature needed for these Learning Day/ Workshops. To better make this information available to every addict, because it is only through understanding and application it works.

The Workshop started with every addict present receiving a Group Booklet. A Resource In Your Community, the 12 Concepts Booklet, and there were 5 Guide to Local Services passed out to GSRs and Alt.-GSRs.

We opened the meeting with a moment of silence followed by the Serenity Prayer, the 12 Traditions and 12 Concepts and Service Prayer were read. The main focus of the day was N.A as a whole, and that we would practice Honesty, Open-Mindedness, and Willingness. We were not here to point fingers or chastise anyone. We were here to look at our assets and liabilities as they were. The Group Booklet was held up and everyone there was asked if they had ever read it all the way through. Only one raised their hand. We began with "What is an NA group?". Concentrating on the six points which describes an NA Group and they relate to our Traditions. The first point was read. We went over the entire Group Booklet from cover to cover, taking breaks on the hour. There were a lot of questions that were asked throughout the day. We went over the autonomy of the Group, and how that autonomy ends with the Group format. There was a lot of discussion on differing formats especially for that of an Open Meeting. How to structure a meeting format to protect our atmosphere, as well as our sacred message of hope, and that is the Group's responsibility

All and all it was a beautiful day. There was so much information covered, it would be difficult to report every detail. The Outreach Committee would like to thank the Mid-West Area for allowing us to come down and participate in their recovery. To be surrounded by fellow addicts who are seeking a better way of life. It was truly a joy.

Next the Outreach Subcommittee went to the Greater Smokey Mountain Area on January 26, 2008, and was asked to facilitate an Outreach Learning Day/ Workshop. Dale S., Lynn S., and William E. were the facilitators of this Workshop. This would be the first Outreach Learning Day in the Volunteer Region. The Committee would like to thank the Greater Smokey Area for allowing us to come down and facilitate this workshop. It was truly a joy.

The meeting was opened with a moment of silence followed by the Serenity Prayer and the 12 Traditions were read. Because of the budget we were able to provide literature for this workshop. # **GNANA Outreach Report**

On December 16, 2007 we completed our Outreach Budget for six months at \$200.00 a month. We will run on this budget for six months and then reevahiate it at the end of the sk months.

In the month of November, Outreach attended the S.N.AG Group in Smyrna Our findings were that an N.A group was meeting in an AA Meeting Clubhouse. The atmosphere oi the meeting was compromised due to an implied affiliation with AA What we mean by this is.

there was AA Literature for sell, members identifying themselves as addicts and alcoholics, and just simply as alcoholics, and AA big books on the table mixed in with NA Literature.

Outreach spoke with a Home group member about the Area's concerns surrounding the S.N.A.G. Meeting. Outreach suggested that the Meeting move to a different room where AA is not so visible. If they were unable to get support from GNANA members, the meeting will want to move, to a location where there will be no implied affiliation with any other Fellowship. The Outreach Subcommittee talked with this member about the six points that define an NA Group and the 6<sup>th</sup> Tradition. We were well received and were thankful and looking forward to us returning.

Outreach attempted to attend the New Beginnings Group in Springfield. When we arrived no one was there. We received the contact number from the Church's Billboard and left a message with the Church explaining the nature of the call As a result of this message, two members of the Group contacted Outreach. The members told us that the addict who started the meeting is no longer around. The Church did not feel comfortable giving the key to an addict who did have any clean time. One of the members of the Church, who is also a member of AA, was given the key and is opening the Meeting. This AA member and another member of that Fellowship have been opening the meeting. The reason the meeting was not open was that these two members are Trusted Servants in AA and needed to attend the AA Assembly in Nashville that Friday night. Outreach told these members that we do not close our doors without prior notification.

Our concerns were clearly expressed. Our biggest concern was would we as Outreach be using NA basket money to an AA meeting, calling itself NA. We as a Committee have decided to attend the meeting while in progress to see if NA Traditions and the Six Points that define an NA Group are upheld.

On December 17\* of 2007, your Outreach Committee attended Brentwood Basics group. We went to the group to help them in any way we could. We found a warm reception and a group with a couple of Home group members. The members of the group told us that primarily they could use our help with formulating a business-meeting format On January 21<sup>st</sup> we will return to the Brentwood Basics group to attend their business meeting, which begins at 6:30 p.m., and we will attend their meeting.

On January 11<sup>th</sup> we went to Springfield to attend the New Beginnings group. We arrived at the meeting at 6:30 p.m., where we found no one there. At about 6:50 pjn. there were addicts showing up for the meeting. These addicts told us that the meeting was open the previous Friday, but that the meeting is not consistently open. The contact number that we had from the previous trip to Springfield was called that night at 730 p.m. We have never received a call back from this group as of yet. We are requesting the direction of this Area on this matter. This is the second time we have gone to attend this meeting and the doors are closed. This is a meeting that is being opened by members of another Fellowship who did not want to see the meeting close down, however we cannot post a meeting on our schedule that addicts will show up to only to find a locked door.

On January 21° we went to the Brentwood Basics group and attended their Business Meeting. We did not cover a lot in the way of having a business meeting. This is a group with two trusted servants who are doing the very best they can to ensure that the NA Literature is

upheld and they are doing a mighty fine job. They will have a literature shipment in by the next business meeting date. We will attend their next Business Meeting on February 18\* at 6:30p.m.

We have tentatively scheduled an Outreach Learning Day for April 12<sup>th</sup>. The VRSC Outreach Subcommittee will facilitate this Learning Day. Our friends and fellow addicts of the Middle Tennessee Area Outreach Subcommittee have been notified and the date seems to world; for them. This date has been coordinated with Activities and both Outreach Committees are looking forward to working with the Activities Committee to provide this function. This Outreach Subcommittee will attend the Regional Outreach Subcommittee Meeting next Saturday in this very room to formally request this Learning Day.

We would like to let the groups of this Area know that we are available to help with Traditions, Concepts, the Group Booklet, the Guide to Local Service, and other Service Manual that NA has to offer. After the Outreach Learning Day we are looking forward to working in conjunction with MTA Outreach to possibly host Subcommittee Learning Days as well

The start up of this Committee has been slow, but after the Outreach Learning Day we will be prepared to bring to the Nashville area the full range of services NA Outreach has to offer.

As a result of our findings on the Springfield New Beginnings Group, the GNANA voted to remove this meeting from our meeting schedule. On our Spring 2008 Meeting Schedule it will reflect this change. #### **Ad-hoc Tax Committee:**

December 6, 2007

Meeting with the State of Tennessee's

Department of Revenue's

Audit Division

Two of your VRSC Trusted Servants, whom were appointed to the Adhoc Committee to find facts on the Tennessee Tax Law, met today with Stacy Gibson, Director of the Audit Division and Stan Dunlap, Associate Director of the Audit Division. We started the meeting out with a Public Information Presentation, so this agency couki come to understand, for them, just what Narcotics Anonymous is and what it is that we seek. After the presentation we were able to

ask questions about our present-day situation surrounding our Literature Committees here in the Volunteer Region.

We began the meeting at 10:00 AM. with the four of us present. The presentation started with the creation of our Fellowship and how we were gifted the Twelve Steps and Twelve Traditions to adapt to our needs as addicts. As a result of this, in 1953, Jimmy K. and fellow addicts in California created what is now known around the world as Narcotics Anonymous. We explained how our primary purpose was different and how we are a separate and distinct fellowship, not to be confused with any other Anonymous program or outside agency that might deal with the disease of addiction. When this Fellowship was formed, it began with 9 Information Pamphlets and the White Booklet, and grew to all the Literature you see on the table. On the table we had the 1) Basic Text, 2) It Works: Ffow and Why, 3) Just for Today, 4) The NA Step Working Guide, 5) A Guide to Public Information, 6) Guide to Local Service, 7) H&I Handbook, 8) Group Treasurer's Workbook, 9) Anniversary Basic Text, 10) Basic Text Tapes, 11) It Works: How and Why Tapes, 12) all the current Informational Pamphlets, 13) the Fellowship Intellectual Property Trust Bulletins, 14) A Resource In Your Community, 15) copies of the original copyrights of NA, 16) VRSC Inc. Corporate Charter, 17) VRSC 501 (3)(c) Tax Exemption Form, 18) VRSC Profit and Loss Statement of the last two meetings, 19) Upper Cumberland Area's Treasurer Report, 20) Key tags, 21) Medallions, 22) literature order forms from the World Service Office, Show-Me Region, Florida Region, the Lone Star Region, and the Upper Cumberland Area, 23) VRSC Public Information Project Map, which lists everywhere NA is in the state of Tennessee.

With the aforementioned presentation items we were able to show this agency just what and who Na is and aspires to be. The Basic Text Project began in 1978 and in 1982 it was made available to the Fellowship. From this all the Literature on the table was created up to the present. We explained using the Fellowship Intellectual Property Trust and Related Bulletins how the Literature we purchase from the World Service Office belongs to the members of Narcotics Anonymous. We showed them how this legal and binding document makes the Fellowship of Narcotics Anonymous the Trustor and the World Service Office of NarcoticsAnonymous the Trustees. We able to show that we of ourselves owned this Literature and we were doing were redistributing what we already own. The infrastructure of NA was then discussed. We showed how the WSO is licensed in California as aNon-Profit Organization and so are our Regions, Areas, and Home groups because we fall under the same umbrella. Our Groups, Areas, and Regions are registered with the WSO as a Narcotics Anonymous entity

We explained how we ordered our Literature from one of the previous mentioned entities of NA (RSO or WSO) and then brought the Literature here to Tennessee for distribution. We explained how we distributed this for cost, where there is *NO* profit made and the bulk majority of it was given away through our various Service Committees. At this point, the members of thi State Tax Office asked us where the funding came from. We then shifted to the 7 Tradition and talked about our donation system using the basket. We told them how our members contributed money to the basket to fund our service endeavors and that no outside contributions would be taken at any time. We were asked, "So your organization will not accept an outside donation?" our response was "Our traditions will not permit it, we would be forced to Tetum it". What this cleared up was that everything we do is centered on our members contributing donations. At this time Ms. Gibson told us that we should not use *sell* and *required donation*, these are terms used in the tax world that imply profit is being made.

We were asked if donations from the basket were our only source of revenue. We answered the question and began to explain how our annual convention operated. We told her that when the Hotel was reserved we submitted our Tax Exempt Form, that the vendors there were licensed from the WSO to use our logos on their merchandise. These vendors were subcontracted and responsible for their own sales tax. Under the agreement with the WSO, these vendors pay \$500 for the use of our logos and then donate anywhere from 25% - 35% of their earnings back to the Fellowship. We showed the agency from the 2006 WSO Report where the Volunteer Region had donated money to the World. We did go into great depth how our funds were used. We discussed that our Home groups used the donations to pay their rent and purchase literature. The excess funds were then passed on to the Area, Region, and/or World Services. At the Area level the donations were used to fund our Service Committees such as P.I., H& I, Phone line, Outreach, Literature, Newsletter, and other various Committees. At the Regional level the donations were used much in the same way, but to support the various Areas the Region serves and in some cases the Groups in the Region when their respected Areas cannot. The donations were then passed onto the WSO to fund their endeavors and the WSO did use these donations to recreate our Literature. The Fund-Flow Chart in a Guide to Local Services and the VRSC P.I. Project map were highly instrumental in helping with presentation of our fund flow and the infrastructure of NA services.

Pamily, what we did know at this point, from now on we MUST use the word DONATION and refrain from sell, sold, profit, and required donation!!! We were told that at first glance it did not seem we were in any violation of Tennessee Tax Law, but to be sure, Ms. Gibson is going to discuss our situation with all the Department Directors to make sure there are no problems. She told that since were purchasing from a Non-profit Organization and then simply redistributing the goods we already own to another Non-profit entity of the original distributor at cost then there is no profit being made, we should be all right. We instructed Ms. Gibson of the Fellowships' fears surrounding an audit. Ms. Gibson's response was "You have taken a proactive approach to obtain a solution. My office is undertaking an already incredible workload; I do not see why we would attempt such a task when there is not an alarm for one. We do not just go after people, especially when they approach us. My main concern is to get NA within the bounds of the Tennessee Tax Laws, to help you do so if need be without changing your purpose". Ms. Gibson instructed us that we would receive a verbal response by phone in around 10 days and that sometime after the first of 2008 we would get something in

writing that will state her findings. Ms. Gibson did take a copy of the VRSC PI Project Map, a Guide to Local Service, the Fellowship Intellectual Property Trust and Related Bulletins, the VRSC Inc. Corporate Charter and Bylaws, the Tax Exemption Form for the VRSC, the Literature Order Forms, the VRSC Profit and Loss Statements, an Upper Cumberland Area Meeting Schedule, the Upper Cumberland Profit and Loss Statement from the last two ASC Meetings, and theNAWS and VRSC Website addresses.

What our findings may mean is that the Areas who mark up the cost of their Literature to cover Shipping Costs, may need to cease with that markup. The markup is a profit. We may find ourselves having to eat the Shipping Costs and redistribute the Literature at the price we had to give depending on the WSO or RSO we order from.

We did state that why we were here is because we had heard of another Anonymous Fellowship being approached by a Government Revenue Department and that we did not want to be guilty of any wrong doing. We were told that the State of Tennessee Department of Revenue Audit Division would check into their case as well, to see if our situation is anywhere comparable to theirs. The agency was aware of all of our fears and concerns. This agency received us warmly.

They did not know who we were or where we are as a Fellowship. We did supply them with all the information they would need to help us in our quest for the truth. There will be ongoing correspondence with Ms. Gibson and Mr. Dunlap until all questions are answered and we can receive a copy of the Tennessee Tax Laws for Non-profit Organizations operating in Tennessee. The meeting was ended at 11:30 AM. In Loving Service, Dale S.

Todd M. contacted Mrs. Gibson Friday, February 1, 2008, she stated that her and Mr. Dunlap had not had the time to get with all the Department heads to go over our situation. She stated that at the present time everything looks greats and we seem to be just fine. She wanted to reassure us that there would be no audit issued no matter what the findings and her Department will work with us to find a solution. We will be to present a written report from this Organization at the April RSC Meeting.

#### **VRCGRC REPORT:**

VRCGRC Ad-Hoc Committee Report February 3, 2008

Hi Family,

I am grateful to be clean today and grateful to be here with you all.

My report starts out with when this subcommittee was formed when I was appointed by the then VRSC Chairperson in October 2006. The first meeting was held at the VRC Convention in Nashville. The revised guidelines being used were then 4 years old and had many problems in them that were voiced by the last four convention committees. There were Traditions violations in the document and hardly any accountability or responsibility. The guidelines were the best we had came up with at that time and were approved by our fellowship as a whole. They were typical with all of our regional services and showed the lack of knowledge of our guiding documents especially the Traditions. The first meeting was a packed house since it was at the convention itself. All kinds of ideas and suggestions were shared and the consensus was to hit some parts here and there and create changes. That was not feasible as there were a lot of problems beginning with the first page. I wrote down many concerns and made a list of items for discussion in future meetings. It was prudent to begin with the first page and since the last procedure worked well (Line by Line) we thought that was the way to begin again. First off we kept the definition of what the VRC is and list who we were responsible to and then came the guiding documents to tell us why we are responsible and how we are held responsible and accountable for all the things we do to put on a VRC Convention. A web page was started up and a lot of people joined the site and I thought it was going to be great with all these interested people. I began looking for other Regional Convention Guidelines, which maybe could help up along with some new ideas. I posted them on the web and started sending out parts of the guidelines for feedback. Nothing came back but for a few meetings held at the Region on Saturday people were still interested in helping. Then the meetings started slowing down until only a few showed up. An interested member who had significant experience at the Region and

on VRC Committees said he was willing to build a guide that we could use anywhere in the region if you were interested in having the VRC in your area. It was called the Hotel Bid Negotiation Workbook and we thought that was a great idea since it seems we try and invent the wheel every time the VRC moves to another city and new people were involved. I have held a meeting at every scheduled Regional weekend. I only missed one meeting but had Kenny Me to facilitate that one. I attended VRC 25 and asked people on the committees for any problems they were having with the guidelines. The VRC 25 Chair gave me a list of items that were all discussed within this sub-committee. I also received suggestions from sub-committee chairs as they were doing their work at VRC 25. Then the last meeting I had at the Convention and no one showed up. This seems to be a trend: There's a problem; We need to get someone to take care of this; We create a committee and then just lose interest; We wait until the finished product is presented after people have put much time and effort into it and then we sit back and throw rocks at them and wonder who do they think they are. That happened the last time these guidelines were revised and has all ready happened just following VRC 25 by one of their subcommittee Chairs. I wasn't willing to spend 3 years on the guidelines this time and end up with the same result. It's only been 15 months working on these guidelines but I feel these are more spiritually based that includes Responsibility and Accountability through the 12 Traditions and 12 Concepts.

Over the years I've watched how the Convention started with the idea of a celebration of recovery for our region and turned into what city could outdo the other cities and accrue the greatest funds to be sent to WSO for the prestige of being one of the top ten providers of money. All during this time, this region had no basic services provided to *help* the suffering addict. It had even crept into our guidelines, which tied our hands so no services could be provided. Money, property and prestige seemed to be the common welfare of each individual city and not the Volunteer Regional Convention being the common welfare for unity in this whole region.

We faced the VRC Guidelines with the purpose of regaining the celebration of recovery principle and not being the monster it has been in even denying Areas and Groups their choice to provide services in their Areas. That is not the example this region needs to be sending to the areas or groups. The VRC also has become its own entity with committees doing whatever they want to and spending funds anyway they want with specialty items for a few privileged members to having rental cars to buying 20 extra meals so they wouldn't have to put themselves out trying to come up with a count with no accountability and hardly any responsibility to the ones they serve. I actually saw a VRC Chair selling unnumbered, unprinted banquet tickets and who knows where the money went

In all the guidelines we looked at, they all had incorporated a system of Accountability to be implemented with their conventions. They all had a Board of Directors (BOD) who was to give direction to the Conventions and to be responsible and accountable with their funds and the operation of the convention. This Region is incorporated for those who don't know and we have a set of by-laws, which this region operates under as a non-profit organization. In these revised guidelines we have included our own BOD. In these guidelines the BOD consists of the: VRSC Chairperson, VRSC Vice-Chairperson, Secretary, Alternate Secretary, Treasurer, and Alternate Treasurer. They should be the deciding point of accountability for all Convention Services performed on behalf of the VRSC, Inc.

Another large item which we have tried to take care of immediately through a motion to remove any direct recruiting of home groups from the VRC Committee. That is a direct violation of Tradition Five as they have only one primary purpose and it's not to make money or provide items to the VRC Committee. This should also not be assumed or recruited from the Areas either. This Committee cannot dictate to any area what they do with their funds from events. The areas should use their funds for whatever they deckle they need to provide services. Even though this item is completely removed from the new guidelines, we knew Chattanooga would be operating under the old Guidelines until the new ones could be approved.

We have incorporated into these guidelines a self supporting process from convention to convention which we feel will alleviate any problems or concerns or fears within the Convention Committee itself. Many times I have been on a VRC committee and we were sweating whether ROR or Surrender Under the Stars or Kiss Kamp out or Memphis in May would come through with the needed funds to carry us into the Hotel and have a successful convention. This process will help in those regards. We suggest keeping a balance of \$15,000.00 from one convention to another convention. The BOD can decide to lower this amount or raise this amount accordingly. What would happen if these guidelines were approved, Chattanooga would receive from VRSC, INC. the remainder of funds to bring their balance up to \$15,000.00 and everything else in these guidelines would be grand fathered into the remaining time of that Convention. This would free up the so called obligation everyone feels they have to provide to the convention and would let the Areas use their funds wherever it is needed, such as providing Services to help the suffering addict who doesn't know we exist.

The checking account will need to be changed in name only to "Doing Business As (DBA) Volunteer Regional Convention, or VRC. No VRC numbers need to be added to the account. (Example: VRC XXVI). Only DBA VRC and then at the end of the convention the treasurer will write a check for everything over the \$15,000.00 continuing balance and make the check to VRSC, Inc. Then the checkbook can be carried to the next Treasurer. Also at this time the signature card can be changed to the new committee. The checking account is to be established with a bank that has branches in all of the major metropolitan areas that host the convention (Page #16 Funding).

Another item that has been a concern with the Convention is the Banquets or meals. Some feel that it is not fair for the ones of us who cannot afford such things. We felt it was an important part of our recovery in that maybe we need to try and work on our self-esteem by dressing up once in a while for something positive and not just dressing up to go to a funeral. I know I needed all the self-esteem builders I could get when I got clean and still do. We felt we offered good food provided in the Hospitality suite, not just peanut butter and jelly sandwiches either, so no one would go hungry. I know when I got clean I couldn't afford the banquets and didn't have any clothes to wear anyway. I went to Hospitality and felt just as much a part of and never left hungry. My first service position on VRC was in the Hospitality Suite. I DEGRESS!!!!!!! Many VRC Committees have suffered over coming up with a count of meals. Others just buy 20 extra meals not knowing whether they would sell or not. That is not very prudent with our funds, just to make it convenient for the Committee. Others have tried to somehow con and manipulate to try and make money on meal tickets. Others say they should be done away with completely. None of these ideas have ever been successful We feel the way to alleviate all these ideas is to

Revise the VRC Flyer itself. We should use the Pre-Registration process with only one flyer. Instead of a pre-convention flyer and then printing another that was fancier; why not just use one fryer. On the flyer would be the artwork chosen for the event, Pre-Registration, Registration, All Meals, speaker tapes, newcomer donation and all ticketed items and all would be listed in a time line (Page #24). Cutoff dates would be published for all items (Page #8). The flyer would be on - our website (www.natennessee.org) in a PDF Format; removing the need for each committee to setup their own site (another waste of NA funds, Concept 11). The cutoff date for meals would give the committee the number of meal tickets to give to the Hotel After the cutoff dates there would be no meal tickets sold. As far as the meals go, that is an important item used in the negotiation of the Hotel Bid Process where the Hotel can make money and we can use as a tool for getting a better room rate. There would be other items such as comedy show that couki be sold up to the event itself because most comedians have a base charge, not a per seat charge.

Another item to be considered in the Hotel Bid Process is the provision of coffee by the VRC Committee. We feel this issue could be handled completely by the Hotel and be a great negotiation tool for us to acquire maybe a better room rate. The funds we use to provide coffee could be used for a greater or primary purpose. In the last six (6) years of the VRC we could only find numbers from five (5) of the conventions and total spent was \$6106.90 or an average of \$1221.38. That is a lot of literature that never will reach the hands of a suffering addict. Also, in those conventions, you can walk around the hotel and see a lot of coffee we paid for was just wasted, full cups of coffee that people had not even used. That average equals out to roughly 122 Basic Texts, or if IP's were \$.23/each that equals 5310 IP's, now tell me what will keep you or especially the newcomer clean.

Some other things need revision for these guidelines to work. The VRSC Guidelines are in a very poor condition, outdated, and restrictive to the spiritual aim this region desperately needs. We suggest to the Regional Body that someone be appointed by the Chairperson to revise 1he VRSC Guidelines. Also these guidelines will require some studying by the Administrative Committee of the VRSC and of the VRC Convention Committees to come. We feel this will work and bring back the convention to a celebration of recovery as it was started out to be. I will be turning in a motion to approve these guidelines and the Hotel Bid Negotiation Workbook for approval as a whole.
