Since there were several members present from GSMANA it was discussed doing something similar between GSMANA and UCANA. There is a no man's

land between the two areas consisting of Rockwood, Harriman, Westel, etc with no NA community (that we are aware of). The joint PI endeavors would consist of distributing flyers with both UCANA and GSMANA helpline and web URL's. Very cool.. excited to see what the future will bring. More will be revealed.
