EASTERN SHIPPING FACILITY CONSIDERED

As part of the preparation of the 1990 WSO budget, a detailed study was conducted concerning the feasibility of establishing an eastern United States printing and distributing facility. The investigation included a site visit to one of the metropolitan areas targeted for the study, to determine lease costs, utility rates, printing costs from local printers, as well as shipping costs for merchandise throughout the eastern part of the United States. An eastern distribution facility would provide additional convenience and speed to the delivery of orders to purchasers east of the Mississippi River.

This information was added to a proposal drafted by WSO staff that, if adopted by the WSO Board, would have scheduled the opening of a full-time shipping and distributing facility east of the Mississippi River.

For the purposes of this study, the metropolitan area of Cincinnati, Ohio was selected as a study option area. Although several other large metropolitan areas in the eastern Mississippi and Ohio Valley areas could be considered and would have resulted in fairly similar expenditure patterns, Cincinnati was selected as being representative of those metropolitan communities.

The proposal for establishing this office included two full-time employees and occasional part-time help, if needed. The proposal included approximately 6,000 square feet of warehouse and office space. This would be adequate to house current and anticipated literature inventory volume for the next two years. The calculation for all expenditures related to this facility for manpower and personnel expense, as well as operational expense for space, utilities, and equipment, represented a total budget of approximately \$178,000. This included approximately

\$40,000 of equipment expense for hand trucks, forklifts, photocopiers, computers, scales and shelving equipment.

In the discussion by the Board, the equipment expenditure was recognized as a multi-year, pro-rated expense. Although the total expenditure would occur in the first year of operation, it was realistic to expect that the impact could be carried over several years. This would have meant, in theory, the expenditure of approximately \$135,000 to operate the facility in the Cincinnati area for a twelve-month period of time.

An analysis was conducted to determine the difference in the cost of shipping orders from Cincinnati as compared to shipping them from Van Nuys. The study revealed approximately a \$28,000 savings in shipping expense. This \$28,000 would be saved expense if the mixture of orders of the study period of the last three months of 1989 had been calculated as a full twelve-month period.

While a savings of \$28,000 is substantial, it would still mean the WSO would have to invest \$107,000 during the coming twelve-month period to operate this office.

The Board decided to table further consideration of this proposal until later in the 1990 fiscal year. There did not appear to be enough money available in the WSO budget during 1990 to accommodate this additional \$107,000 expense. If the fiscal position of the WSO changes, later in the year, this project will be undertaken.

CHANGE IN SHIPPING FEE

In 1989 the World Service Office paid approximately \$56,000 more in shipping expenses than it received in fees charged for shipping. This is the third year in a row that money has been lost to shipping costs. The loss has climbed to a significant figure.

The shipping and handling fee schedule was established in 1985. Instead of the flat 10% shipping and handling fee charged previously, a graduated scale was adopted. The graduated scale was based on an analysis of shipping and handling expenses and estimates of anticipated income from the fee. The fee schedule has, during the last four years, displayed minor errors in calculation from the 1985 decision. This has resulted in the growing financial loss.

As a result of this situation, the WSO Board voted to increase the shipping and handling fees. Effective April 1st, the schedule shown in the following paragraph will become effective for all shipping and handling fees.

We believe that these rates will enable the WSO's shipping department to operate on a fiscal level that is both efficient and effective.

CLEANTIME REQUIREMENT FOR WSO BOARD

At the January meeting of the WSO Board of Directors, the minimum clean time requirement was increased by action of the Board. This step was taken in recognition of the eight years minimum clean time required for other world-level trusted servants elected by the conference. Additionally, the number of members with longer clean time has grown in recent years so that more members are eligible with the new clean time requirements.

The Board elected to establish the clean time requirement for Board membership in 1990 at six years, and adopted a provision to increase the clean time requirement to eight years during the succeeding two conference years. Members interested in receiving nomination to the WSO Board at the upcoming World Service Conference should keep in mind the new minimum clean time requirement.

LAWSUIT NECESSARY

In recent *Fellowship Reports* and *Newslines*, the WSO reported that an effort has been made to encourage private vendors to voluntarily discontinue the use of the N.A. logo in privately produced merchandise. While many of these requests have been met with compliance by vendors, there are a few companies who have refused to cooperate.

After considering the facts, the WSO Board was forced to proceed with a lawsuit against the first vendor who has been unwilling to comply. This vendor was served with a complaint by WSO attorneys in January. The response time for the complaint is late February, and the results are not known at this time.

In a distantly related matter, a treatment trade publication recently printed a front page article about trademark registration and trademark violation with respect to the A.A. fellowship. They have also recognized the seriousness of this matter, and have put the industry on notice of their willingness to take trademark violators to court.

This independent action by the other fellowship is further recognition of the significance that trademark and copyright infringement has to any fellowship.

We do not believe the fellowship wishes to become engaged in litigation. The decision to seek settlement through litigation was made only as a last resort. Every reasonable effort has been made to induce the violators to cease their action, so that a lawsuit would not be necessary.

The WSO has received admirable cooperation from many vendors, as well as excellent cooperation and information from our members. The WSO continues to receive new information from members about individual stores and private producers who are manufacturing and selling items that display the N.A. logo. If you have additional information about manufacturers or private vendors trading in merchandise using the N.A. logo, please direct that information to the World Service Office.

NO BOOKSTORE SALES AT THIS TIME

Capping a three-year study by the WSO Board and a book consultant, the WSO elected to decline offers to make the Basic Text available in commercial bookstores.

For three years, the WSO staff and Board studied the pros and cons of making the Basic Text available in bookstores. The study revealed that our current price structure would require a significant change in order to realize a profit on bookstore sales, due to the discount system used in the bookstore trade. The price change would then create further problems.

In order for Basic Text revenue to remain at its current level, a commercial retail price of about \$15.00 would have to be established. While many books with production qualities similar to the Basic Text are indeed in the \$15.00 range, it has become very clear that such a price would cause an enormous disruption in the availability of the text through existing non-fellowship customers of the WSO.

As an example of the problem, the Board considered a proposal from a book distributing company which was interested in handling the distribution of the Basic Text to commercial bookstores. In order for this to have been viable for the company involved, it would have required the price of the book to be established at \$14.95. If this proposal had been accepted, all non-fellowship sales (current WSO customers, treatment programs, government agencies, etc.), would have to be adjusted to the new price. Normal discounts would be applied to the new retail price, but the increased price would significantly increase the cost to treatment programs.

We believe the significant increase in the price would have substantially reduced the number of treatment programs and non-N.A. customers who purchase the N.A. Basic Text. The amount of estimated sales through bookstores would not offset the decline in direct sales to WSO's current non-member buyers.

Adoption of the bookstore proposal would mean a potential loss in revenue to the WSO of significant proportions. Additionally, it would deprive many addicts in treatment of the availability of the Basic Text, as many treatment programs would cease to purchase the book.

The WSO Board still believes there may be an opportunity to carry the message to addicts through commercial bookstores. However, it does not seem practical at this time to enter into the type of sales agreement that would be necessary to facilitate this.

The matter will be reviewed further and considered by the Board at a later date.

CANADIAN LITERATURE SALES

In the last *Newsline*, a brief article discussed the change in fees charged by Revenue Canada for the importation of some WSO literature and other items. We completed a detailed and thorough analysis of the impact of these changes, as well as the impact of current shipping rates and discount schedules during the closing months of 1989.

The results of this study were presented to the WSO Board at its January meeting, along with a recommendation for adapting to these circumstances. The report revealed that the WSO would expend approximately \$35,000 in shipping costs and taxes to make the literature currently used in Canada available to our Canadian members. A detailed analysis of options revealed that it would be practical to open and operate a limited shipping facility in Canada for approximately \$41,000.

With the difference between the loss to WSO for expenses, discounts and taxes, and the cost of operation, the WSO Board elected to expend the additional funds to open a branch shipping office. This office will improve the convenience and speed of providing literature and other inventory items to the fellowship in Canada. The WSO staff examined several different cities and recommended that the office be placed in a suburb of the city of Toronto, in Ontario, Canada. The Board adopted that recommendation, and during the next few months a reasonable industrial space will be secured.

In addition to opening the shipping office, the WSO will seek to produce as many of the inventory items in Canada as can be arranged. Prior investigation in this matter revealed that most inventory items of literature can be printed economically in Canada. This is positive, even though the quantities upon which these estimates were based are much lower than the quantities produced in Van Nuys. If Canadian manufacturers can be found for keytags, chips, and medallions, WSO will shift the production of these items also.

The WSO will be looking for a member of the fellowship in the Toronto area to fill this part-time position (ten hours weekly), beginning in April. Members interested in working for the WSO in this way should contact the WSO at their earliest convenience.

We anticipate that all orders to be shipped from this facility will still be processed through the World Service Office in Van Nuys. Those orders, once received at WSO, will be dispatched to the shipping office in Toronto by computer or by overnight mail. It will then be possible for Canadian members to purchase literature without having to convert the purchase price from Canadian to U.S. currency. The WSO currently has bank accounts in Canada that will be able to handle these transactions through the mail.

Delivery of orders will be expedited, because Canadian customs will no longer be involved in each shipment. Items that require customs clearance will be sent in direct shipments to the office once it is established. This will substantially reduce the inconvenience and time delay members experience when ordering literature from Van Nuys. More specific details will be sent to the Canadian service boards and committees, and to other interested parties, as plans progress.

This branch office will not provide other communication services, so all group services, H&I, P.I., and similar matters should continue to be addressed to the World Service Office in Van Nuys.

This change in operational policy will facilitate a change in the discount schedule for purchases made by Canadians. That change will be included with the information sent throughout Canada in the months ahead.

JEWELRY

Another important item considered at the WSO Board meeting in January was the implementation of a plan resulting from the decision by the conference last April to have WSO make available jewelry sales that includes the N.A. logo.

The staff presented a proposal to establish a threeyear pilot project to produce or receive from current producers a supply of jewelry items which the WSO would then make available for sale to members and service committees. The proposal included a stipulation that companies providing jewelry for this pilot project be required to sign an agreement to discontinue independent sales to individuals, boards, and committees, and agree that all sales be handled through WSO. The proposal called for WSO to stock these items in its inventory, either at the office in Van Nuys or through contract at a different location. When orders are received, jewelry items would be shipped by a secure shipment system, such as registered mail or registered delivery through a private delivery company like UPS or Federal Express. All items shipped from WSO would be insured at the expense of the purchaser and would require a receipt for acceptance of delivery. All orders would require payment in advance, including shipping and handling fees, before orders could be processed.

A special provision would be available for service boards and committees, particularly conventions, that wish to have a display of these items available at their event. This would entail additional security and financial requirements for the service board or committee. However, it is anticipated that with direct sales available from WSO, the demand for some jewelry items would decrease from the level of demand at many conventions in recent years.

The proposal included a requirement to produce a separate catalog containing information about jewelry items, and that this catalog be independent from the WSO literature catalog.

The proposal adopted by the Board calls for a pilot project, during which manufacturers would be invited to send to the WSO sample items they currently produce. They would also be asked to provide evidence and other information concerning the length of time such items have been produced. The WSO is not interested at this time in encouraging new suppliers or manufacturers; it wishes to identify and facilitate the use of existing manufacturers. These existing manufacturers would be relied upon for the first two or three years to produce and supply WSO jewelry items. A bidding procedure would then be established for future sales, to open competition for new manufacturers.

This approach was selected as a means of providing an adequate incentive for existing manufacturers to appropriately scale down and then eliminate their independent use of the fellowship trademark materials, and to avoid adding the complication of inviting new competitive suppliers.

The project will make it possible to determine whether this is a practical solution to the illegal and

improper use of the N.A. logo and jewelry manufacturing, and provide an opportunity to end these practices.

As a follow-up, it would provide opportunity at the end of three years to develop a bidding system to provide the fellowship with quality material at the lowest possible price. The WSO invites current manufacturers to communicate to Anthony E. of the WSO staff for participation in this conversion pilot project. The WSO hopes to be able to report progress on this matter at the World Service Conference, and to have this pilot project in operation during the first half of 1990.

MEMBER SURVEY

Thanks to all of the areas who have chosen to participate in the member survey. We have sent out over 1,800 individual surveys to fifty-one areas, as of this printing of the *Newsline*. We now need to ask that the surveys be completed and returned to the WSO as soon as possible. Summarizing the information from the survey is very important to the efforts of public information in Narcotics Anonymous.

Once again, thanks to all of you for participating. We hope to have preliminary information available at the WSC in April.

TRADITIONS AD HOC COMMITTEE

The committee met in Van Nuys on January 12, 13 and 14. The report of the meeting is now available and has been mailed to all WSC participants and registered regional literature committees.

A book publishing consultant was present for the discussions and provided some advice about processing content-related input, compiling chapter outlines, style guidelines and timetables, and the eventual production of drafts.

The report contains a detailed discussion of the committee's ideas about possible pre-review and

review processes for the chapter drafts. WSC actions will definitely have impact on this aspect of the project, and the committee will wait until after the conference to finalize its plans in this respect.

There was also discussion about the need to clarify some inaccurate information pertaining to the input which is on file at WSO. The following excerpt from the report is reprinted here for the purpose of providing accurate information:

"For example, minutes from a recent multiregional meeting contained a quote referring to 'five drawers of traditions input on file at WSO.' In reality, input is contained in parts of five different drawers, but the drawers are not filled completely with traditions input. The amount of material totals approximately 2,409 pages and can be categorized as follows:

Traditions Input Book (brown): 383 pages Additional Material (referred to on page vi of Traditions Input Book): 1,698 pages Input received since 1/89: 308 pages Recent letters: about 20 pages

There are also drafts and notes used in preparing the original blue review draft of It Works: How and Why, which included both the steps and traditions. This, along with the 1986/1987 Unpublished Draft, Newsline articles, and miscellaneous input received prior to 12/88 was all included in the brown Traditions Input Book."

The WSC Literature Committee chairperson and another WSCLC member also attended part of the meeting. Communication between the steps group and the traditions group is proving to be beneficial to all involved, and will continue.

A meeting scheduled for February was cancelled. The Traditions Ad Hoc Committee will meet with the BOT in March, and has also scheduled a meeting for early April.

FROM THE LITERATURE CHAIRPERSON

Again, a reminder to all literature chairpersons that the WSC Literature Committee mails reports to registered regional and area literature committees. For this mailing, we don't distinguish between literature committees and literature review committees. So if you have two literature committees in your area or regional service committee, you should choose one to receive regular communication from the WSCLC. Your local committee can then further distribute this information.

There seems to be confusion among some literature committees about the status of the project, *A Guide to Service in Narcotics Anonymous*. This is *not* a piece of review-form literature. It is the responsibility of the WSC Ad Hoc Committee on N.A. Service. Any reports or solicitation of input on this document has come from that committee, *not* the WSC Literature Committee. Any comments, suggestions, input or questions should be directed to that committee c/o the WSO.

Both the WSCLC and the Steps Ad Hoc Committee are looking for ways to reduce the lag time for these reports. Hopefully, the following information will explain more clearly how we go about making these reports available.

There is a standard procedure that occurs before a Steps Ad Hoc Committee report can be produced and published. After each meeting, the minutes are transcribed and a general report is drafted. These are sent to the ad hoc committee members for their review and comments. Changes are made and the report is approved at the next meeting. It is then sent to the WSC Literature Committee for their review and approval. After they have looked over the report, it is then mailed out to conference participants and regional literature committees. As you can see, time is needed for each of these phases. Although this seems like a long process, it actually serves as an additional way to evaluate the ad hoc group's work. This is simply one more avenue that the WSCLC uses to maintain responsibility for its projects. We appreciate everyone's interest and patience in this project and will continue to communicate our ongoing work.

DECEMBER STEPS AD HOC REPORT

This is a shortened version of the report from our December meeting. A more detailed report of this meeting was mailed to all conference participants and regional literature chairpersons.

The Steps Ad Hoc Committee met the weekend of December 9th and 10th in Van Nuys, California. The first item on the agenda was review and discussion of fellowship input. Input from the New Jersey RLC, The Cape Atlantic ALC, the Pittsburgh ALC, the Ohio RLC, the Volunteer RSR, the Lisbon ASR, and the N.E. Mississippi ALC was distributed to the ad hoc group. This was all of the input received this conference year relating to the Steps Ad Hoc Committee's work. Most of the input was general and concerned the staff team approach or the *It Works* report of October 13.

The next discussion the committee engaged in concerned the Traditions Ad Hoc Committee reports, future communication and sharing of information between the two groups. We talked about sending a member from our committee to the traditions group every so often to maintain a working relationship as well as to observe, first hand, their discussions on the traditions project. We anticipate that the Traditions Ad Hoc Committee will likewise send someone from their group to visit our committee. This type of interaction would provide a valuable perspective for both groups, and perhaps help alleviate some duplication of effort. Another important aspect of this discussion was the issue of whether or not the steps and tradition portions would be contained in one book or two. The consensus of the group was that it was important for the two sections to be contained in one book, regardless of whether they had similar or compatible writing styles. After a lengthy dialogue, we concluded that different writing styles were a concern secondary to the value of having the steps and the traditions in one volume. However, the committee felt strongly that this is a decision that should be made by the fellowship. Some members of the group believe that this discussion should be brought before the 1990 WSC for a decision.

At this meeting, the ad hoc group had, as its goal, the development of outlines for chapters on the first six steps. By the end of the meeting on Sunday, we had completed outlines for the first five steps and had a solid beginning on Step Six.

We began with a general review of the work from the October meeting, which included a report, minutes, and input from the WSC Literature Committee meeting in St. Louis. The next topic covered ideas to be considered for an introductory chapter to the steps portion of the book. Much of this discussion centered on sponsorship, and the terms that could be used to explain common experiences. The central thought for this was that there are many principles that work hand in hand with one another throughout the steps, and at times many of the words we use to describe spiritual principles are interchangeable. The feeling was that all the various levels of recovery and understanding will determine how we, as individuals, will define these terms, and as long as the writing relates to the reader as an equal, we won't have to worry about all the terms that are particular to Narcotics Anonymous.

Instead of the usual dissection of the steps word by word or by groups of words, the committee decided to take a more general look at the overall feeling and action underlying them. Each chapter outline began with a standard question to stimulate discussion: "What principle(s) and identification can we discover in this step?" From there, the committee looked for a predominant theme in each step and any corresponding thread(s) that could be common to either all or groups of the steps. Sponsorship is one point that we agreed could be mentioned, however briefly, somewhere in each step. Another point the group considered was the commitment to recovery they feel is inherent in the steps. Factoring all of these ideas into each outline is not as easy as it seems, and the first step required considerably more effort than the following outlines.

Discussions on the various step outlines have, for the most part, flowed easily between all the members of the group. The ad hoc group expressed a sense of unity and excitement in developing these outlines, and looks forward to working on the remainder of the steps.

1990 WORLD SERVICE CONFERENCE

The 1990 meeting of the World Service Conference will begin on Monday, April 23, 1990, in Van Nuys, California, at the Airtel Plaza Hotel. An orientation session will be held on Sunday, April 22, beginning at 5:00 p.m. This session will entail a brief discussion of the WSC rules of order. Conference officers, committee chairs and vice chairs, trustees, and other

trusted servants will be introduced, along with WSO staff members who will be assisting at the conference. The orientation session is designed to help conference participants feel more comfortable, and to help us accomplish the work of the conference in an orderly manner.

Room rates for the conference are \$84.00 per day (\$75 plus 12% tax). A block of rooms has been set aside for us, and they will be assigned to conference participants first. If you are a conference participant, but you have *not* received a room reservation form, please call the office (818-780-3951) and request one from Ann or Lori. You must reserve your rooms through the office in order to receive the special rate.
