ACTIONS AND REACTIONS TO A VISIT TO THE ORIGINAL ARCHIVES OF  
NARCOTICS ANONYMOUS FOR INFORMATION FOR THE WORLD SERVICE OFFICE AND  
THE FELLOWSHIP OF NARCOTICS ANONYMOUS THROUGH THE WORLD SERVICE  
OFFICE.

DEAR SIRS:

ON AUGUST 14 AND 15, 1992, MR. CARL DEAL AND MR. BILLY ALLEN,  
REPRESENTATIVES AND INTERROGATORS OF AND FOR THE EAST COAST HISTORY  
COMMITTEE KNOWN AS AND COPY RIGHTED AS THE NA SOCIETY BY ADDICTS FOR  
ADDICTS.

REPRESENTING THEMSELVES FOR THE PURPOSE OF OBTAINING INFORMATION FROM  
THE NARCOTICS ANONYMOUS ARCHIVES OF ITS FOUNDER MR. JAMES (JIMMY)  
KINNON.

THIS COMMITTEE FEELS AND IT IS OUR OPTION THAT THE N.A. SOCIETY  
COMMITTEE VISITING THE ARCHIVES IS WAS NOT CONFORMING TO THE PROMISES  
THEY HAVE MADE SUCH AS DENYING JIMMY KINNON AS THE FOUNDER OF  
NARCOTICS ANONYMOUS IN SPITE OF REVIEWING FOUR OR MORE DOCUMENTS FROM  
THE ARCHIVES THAT:

1. SHOWED THAT A COMMITTEE WAS MEETING FOR THE FIRST TIME ON AUGUST  
15, 1953 TO DISCUSS THE STARTING OF NARCOTICS ANONYMOUS AND GIVING IT  
A NAME PRIOR TO THE FIRST MEETING AND FORMATION OF NARCOTICS  
ANONYMOUS ON OCTOBER 5, 1953. THE TRUE BIRTHDAY OF NARCOTICS  
ANONYMOUS AS WE KNOW IT TODAY.

2. DOCUMENTATION THAT INDIVIDUALS WERE MEETING JUNE 30, 1953 AND  
BEFORE WHICH WAS BEFORE BECOMING AN OFFICIAL COMMITTEE. THESE  
DOCUMENTS SHOW THAT JIMMY KINNON WAS THEIR AT ALL OF THESE MEETINGS  
AND THAT ALL THESE PEOPLE HAD TURNED OVER DURING THIS PERIOD OF TIME  
EXCEPT JIMMY KINNON WHO CALLED THEM ALTOGETHER.

3. DOCUMENTATION THAT JIMMY KINNON CONTACTED SEVERAL OTHER

ORGANIZATIONS WHICH HAS AN INTEREST IN HELPING ADDICTS RECOVER TO SEE WHY THEY WERE FAILING INCLUDING THE CORPORATION KNOWN AS THE NATIONAL ADVISORY COUNCIL ON NARCOTICS, INC. WHICH WAS NICKED NAMED NARCOTICS ANONYMOUS AND WAS APPROVED TO HAVE MEETINGS INSIDE FEDERAL PENITENTIARIES AND HAD ONLY 2 TO 10 MEMBERS AT VARIOUS TIMES MEETING IN A ROOM MADE AVAILABLE FOR THE CORPORATION NAMED ABOVE USING THE NAME NARCOTICS ANONYMOUS WHO AS TRYING TO USE THE 12 STEPS OF ALCOHOLICS ANONYMOUS AND SOME TIMES RE-WRITTEN IN THEIR OWN WAY AND SOME TIMES 13 STEPS AND PRACTICED NO TRADITIONS THIS WAS ONLY AN ATTEMPT WHICH FAILED WITH NO CARRY OVER TO OUR PRESENT DAY NARCOTICS ANONYMOUS.

4. DOCUMENTATION THAT JIMMY CONTACTED PERSONS INVOLVED WITH THE LEADER OF NATIONAL ADVISORY COUNCIL ON NARCOTICS, INC.,, MR. DANNY CARLSON BEFORE ANY OF THE STATED ABOVE OCCURRED.

5. DOCUMENTATION OF JIMMY KINNONS VISION WHICH WITH ALL OF THE ABOVE SHOWES DOCUMENTATION PROOF OF THE FACT THAT IN FACT JIMMY KINNON IS\WAS\AND ALWAYS WILL BE THE FOUNDER OF NARCOTICS ANONYMOUS.

EVEN IN THE LIGHT OF THE PROOF THE NA SOCIETY REPRESENTATIVES REVEALED TO THIS COMMITTEE THAT THEY ARE PLANNING TO BREAK THE TRADITIONS OF OUR NARCOTICS ANONYMOUS BY INCLUDING IN THEIR HISTORY BOOK A SECTION ON EARLY DAYS PRE 1953, FIRST MEETING, WHICH IS A HISTORY OF ATTEMPTS TO HELP ADDICTS BACK AS FAR AS 1812, SUCH AS; TEMPERANCE MOVEMENTS, SOCIETIES, AND ENDEAVORING TO CONNECT A FLOW WITH WITH NATIONAL ADVISORY COUNCIL ON NARCOTICS, INC., (N.A.) IN FACT WHEN THEIR WAS NO CONNECTION. ANY PRE INFORMATION IS AN OUTSIDE ISSUE AND HAS NO BEARING ON OUR PRESENT FELLOWSHIP. ANY ATTEMPT TO DO THIS IS A BREAK\BREACH\VIOLATION IN THE 12 TRADITIONS OF N.A. THESE N.A. SOCIETY COMMITTEE REPRESENTATIVES WERE TRYING TO TAKE WITHOUT PERMISSION, ORIGINAL WRITINGS EI., STORIES IN THE PAMPHLETS, BASIC TEXT, WHICH WERE JIMMY KINNON'S PRIVATE WRITINGS AND OWNERSHIP.

THEY WERE ALSO TRYING TO GET COPYRIGHT INFORMATION AND DOCUMENTATION FOR THE FIGHT WITH THE WORLD SERVICE OFFICE, INC., PRESENTLY BEING FOUGHT IN COURT.

IT IS WITH GREAT RESPECT AND HONOR THAT THIS AD HOC COMMITTEE KNOW AS "THE JIMMY KINNON NARCOTICS ANONYMOUS FOUNDER, ARCHIVES, HISTORY, AD HOC COMMITTEE", ALSO KNOWN AS J.K.N.A. COMMITTEE, APPRISES YOU OF OUR FINDINGS. AN IMMEDIATE MOTION OF THE JKNA COMMITTEE WAS MADE TO STOP THE RESEARCH OF THE NA SOCIETY COMMITTEE AT THIS TIME FOR THEIR STATED INTENTIONS TO VIOLATE THE 12 TRADITIONS OF N.A. AS EXPLAINED ABOVE., JKNA COMMITTEE HAS STATED ITS PURPOSE AND SHALL FOLLOW THROUGH WITH THE PROTECTION OF JIMMY KINNONS PERSONAL BELONGINGS \ ARCHIVES TO REVIEW AND MAKE SAME AVAILABLE TO THE FELLOWSHIP AND ANY CONCERNED GROUP, INCLUDING THE N.A. SOCIETY. SAID INFORMATION SHALL BE AVAILABLE AS PER JKNA COMMITTEES GUIDELINES.

OTHER INFORMATION THAT THE WORLD SERVICE ORGANIZATION AND BOARD OF

TRUSTEES SHOULD KNOW IS THAT THE N.A. SOCIETY REPRESENTATIVES ALSO SHARED THEIR INTENT TO GAIN COPYRIGHT ACCESS AND TO BRING DOWN THE WORLD SERVICE AND RISE OUT OF THE ASHES AS THE PHOENIX WITH DIRECT CONTACT ONLY WITH INDIVIDUAL MEETINGS. OTHER STATED PLANNED BREAKS OF THE TRADITIONS IS TO WRITE ABOUT PERSONAL LIVES, HOUSES BURNED DOWN, RECOVERY HOMES, AND ETC.

ALSO WOULD LIKE TO NOTIFY EVERYONE THAT THE JIMMY KINNON PERSONAL ARCHIVES ARE NO LONGER LOCATED AT MRS. BETTY KINNON PERSONAL RESIDENCE.
