Foreword

he theme of this year's Annual Report came from the 2006 World Service Conference theme, "It's All About Carrying the Message." As a worldwide fellowship, we have set our sights high in the NA World Services Vision Statement. The goal of our work together is that no addict need ever die from the horrors of active addiction. Everything that we do to move closer to realizing our vision will result in progress beyond measure toward providing hope and freedom to people like us who didn't know they had a choice.

The worldwide Fellowship of Narcotics Anonymous continues to grow, by leaps and bounds in some places, more slowly in others. NA World Services is beginning to break stride as we continue to learn new ways to understand the needs of local NA communities everywhere and as we support them in their efforts to grow. The evolution of Issue Discussion Topics has been like a fellowshipwide inventory, and with regard to many of the obstacles we face, we seem to be moving into a sixth- and seventh-step process of shedding our immaturity as a fellowship.

The course of this fiscal year for NA World Services and the Fellowship of NA has demonstrated our willingness to look ahead. The work described in this report is the work that we all do together to ensure that NA's ability to provide hope and freedom to still-suffering addicts long after we're gone. It really is all about carrying the message.

From Your World Board

he purpose of all of the work that we do together as a fellowship, in local NA communities and through NA World Services, is to reach those who haven't yet heard our message of recovery. The NAWS vision represents the primary purpose of our groups as it applies to our collective efforts in service to carry the message to addicts seeking recovery all around the world. This *Annual Report* will provide a brief summary of what we have all done together to work toward that goal in the last year, as well as what we see on the horizon for the coming year.

The world convention took place in Hawaii in the first half of the fiscal year and the 2006 World Service Conference took place in the second half. These major events, along with our efforts to prepare for the conference and follow up on the work that began there, have made for a very busy year. In addition to our work on the Basic Text and Public Relations projects, we have participated in zonal forum meetings throughout the US, as well as at the Canadian Assembly, the European Delegates Meeting, the Latin American Zonal Forum, and the Asia Pacific Forum.

Throughout the last conference cycle, the fellowship as a whole took part in ongoing discussions on the topics chosen at WSC 2004: Atmosphere of Recovery, Infrastructure, and Our Public Image. With feedback from the fellowship and ongoing discussion in zonal forums and workshops, the discussions grew and changed. The energy and ideas from these conversations came together at WSC 2006 when participants held the final discussions on those topics. That energy and those ideas became the input for the coming cycle's work plans. They also made it possible for conference participants to choose new Issue Discussion Topics, including Building Strong Home Groups, Who Is Missing from Our Meetings and Why, and Our Service System. These topics arose directly from the previous discussions and represent our cooperative efforts to find solutions at the local, national, and worldwide levels.





This process is relatively new and we are very pleased with the efforts of so many members to help make it work. As we all discuss these issues together, we can continue to identify solutions and practices that work best. Your conversations with each other at local levels and our conversations with you at workshops throughout the cycle impacted the work that we proposed to the conference for the 2006-2008 conference cycle in an unprecedented way. We will continue to work to improve the process of gathering real input and ideas, and are confident that this will continue to help us to mold ongoing discussions and incorporate IT'S ALL ABOUT solutions into our work. We are excited and confident about these opportunities to strengthen our partnerships with regional delegates and their partner-LLT HANDLAR OM ATT FÖRA BUDSKAPET VIDA ships with each other. With من أجل حمل الرسالة SE TRATA DE LLEVAR EL MEN so much going on all around the world, regional delegates provide an immensely valuable resource in our efforts to support the fellowship's trusted servants at all levels.

WSC participants also selected seven World Board members, one new WSC cofacilitator, and two new Human Resource Panel members for the coming conference cycle. A number of board members completed their terms at the conference this year, including Saul A from Panama, Giovanna G from Cartagena, David J from the UK,

Bob J from Florida, and Daniel S from Frankfurt, Germany. On behalf of NAWS and the worldwide fellowship, we express many thanks for these members' generous contributions of commitment, dedication, and a whole lot of work. Their combined experience represents decades of commitment and perspective. They will each be missed, but we trust that their service, past and future, will continue to touch the lives of many people in and out of the program.

We want to thank HRP members Francine B from Montreal and Tali Mc from Hawaii, and co-facilitator Romanness Education of the Conference of the completed their service terms at the conference this year.

We would also like to thank the conference participants for all of the energy and enthusiasm they brought to WSC 2006. We appreciate the trust and confidence they placed in our five new and two returning board members.



Project Updates

Worldwide Workshops

The final Worldwide Workshop of the 2004-2006 conference cycle took place in Lisbon, Portugal, in November 2005. Worldwide Workshops are adapted to fit the local community, and in Lisbon that meant beginning Saturday morning and ending Sunday night, instead of starting Friday evening and ending Sunday afternoon. Participants were updated on NAWS activities, including projects that were entering their final stages for the conference cycle. The members were introduced to the small-group process as they participated in a town hall meeting. They discussed some of the issues of local importance, including a lack of clean time and sponsorship in service. They discussed possible solutions to these problems, including the idea of working hard to make sure that service is an encouraging, inviting atmosphere for everyone. Other sessions focused on the Issue Discussion Topics, and members discussed the variety of challenges they faced and a number of possible solutions, including those that were already working in some communities. Members also discussed the issue of leadership in NA and ways that we can all try to cultivate good leadership qualities in NA service. Finally, the members who participat-

ed in this workshop talked about what they learned over the weekend and expressed their intentions to take the solutions back to their home groups.

We also hosted two Eastern European workshops in the Ukraine and Lithuania. NAWS funded travel to these workshops for an unprecedented number of participants from countries ranging from Slovenia, Slovakia, and Croatia to the easternmost parts of Siberia. The workshops were held in English and Russian, the two most commonly understood languages among delegates with a vast range of mother tongues. The languages spoken by participants in these workshops

included Ukrainian, Slovenian, Slovakian, Moldavian, Polish, Latvian, Lithuanian, Estonian, Serbian, and Croatian. Participants discussed a wide variety of issues that affect these local communities. One of the topics of importance to these communities, of course, was translations. We are very pleased to announce that, by the time this Annual Report reaches publication, a Russian Basic Text, recently revised for terminology, should be available. We were happy to play a small part in this process, but little would have happened if not for the extraordinary fellowship development efforts that the Western Russian Region and other communities in attendance undertook on their own. Many thanks and congratulations to you all! And thanks also to the many delegates from the European Delegates Meeting who stayed to help support the workshop in Lithuania.

Representatives from NAWS traveled to Bangkok in February to participate in a translations workshop and at the Asia Pacific Forum (APF), where they facilitated two workshops. They also attended Malaysia's first convention, which was held in Kuala Lumpur. The APF provided us with the much-needed chance to address a variety of issues with representatives from many communities, including translations issues. Several NA communities in that part of the world, such as Pakistan, Nepal, Indonesia, and the Philippines, have translations in progress and complex issues to resolve. Several of these communities had requested our assistance in the form of a workshop, and the translations workshop, in conjunction with the APF, made it possible to assist them in their efforts to make the NA message more readily available in their communities. The translations workshops will be

discussed further in the Translations and Fellowship Development section.

NAWS staff wrapped up these two rather ambitious trips with a stop in Iran on the way home. Throughout the year, the NA community in Iran continued to experience unbelievable growth in numbers and recovery strength. We are doing everything we can to support our new branch as well as the regions, areas, and members in Iran. Much of the entire fellowship has become entranced with the size, growth, and enthusiasm of Iran. They are truly an example of what happens when unity becomes foremost, services are organized and well thought-out, public relations efforts constantly remain a priority, and carrying the message is always foremost in their minds. We can all learn something from what they have done and continue to do.

Basic Text Project

While this Annual Report covers the period July 2005 through June 2006, we will take a bit of a broader view for the Basic Text project. This project spans several fiscal years and two conference cycles, beginning in 2004 when the World Service Conference passed a motion to revise the Basic Text. That motion was to replace some or all of the personal stories and add an introduction to this part of the book, and to add a new preface to the book as a whole.

The initial stage of the project involved plotting the process that would follow. Then, in February 2005, we began to solicit new personal stories from the fellowship. The solicitation effort, which extended through the first part of this year, was devoted to collecting submissions and beginning an evaluation process. December 2005 marked a formal end

to the collection period, but we continued to accept submissions for some time afterward. Altogether there were more than 700 submissions from thirty-four countries:

The workgroup read and evaluated all of

these pieces as well as the personal stories already published in the English, French, and Dutch Basic Text and the Swedish and Anglicized White Booklet. The 2006 World Service Conference approved the project plan for the 2006-2008 conference cycle. As the fiscal year drew to a close, the

work of putting the text together was well underway.

September 2006 was a milestone in the project. On the first of the month, a draft of the text was mailed out for review to all members who requested one, as well as to all regions, areas, and conference participants. The draft will be out for review for six months, and then it will be revised again to incorporate fellowship input. The draft that results will be released in September 2007 for the approval phase. The review draft includes a new preface,

a new introduction to the personal stories section, tentatively called "Our Members Share," and a revised set of personal stories/members' sharing.

One of the primary impetuses for the revision was to collect a set of shared experience that better represents the diversity of today's worldwide Fellowship of NA. The fifty-one longer pieces and several collections of shorter reflections go a long way toward meeting that goal. We do still hope to add some pieces to fill out some of the thinner spots in the collection, such as gaps in some of the geographic diversity. Still, the wide span of ages, nationalities, and cultures represented by pieces in the review and input draft demonstrates the broad range of the text and of our worldwide fellowship.

In the first two months of release, thousands of copies have been mailed out and downloaded. Many local communities are holding review workshops, and input is coming in from individuals and groups and committees. We look forward to the work in front of us in

the fiscal year ahead. Incorporating the input from the fellowship and working to collect some additional material promise to make an even better text for fellowship consideration. Our Basic Text tells us, "Our faith, strength, and hope come from people sharing their recovery," and when we share our recovery in print, it reaches so many members and has the capacity to help so many addicts.

Public Relations

Conference Project

The Public Relations Handbook workgroup, composed of members with relevant and varied service experience, completed its charge with the creation of the Public Relations Handbook. The handbook was then approved unanimously by participants at WSC 2006. World Board member Ron M worked with seven US members and four international members on this project. Work will begin on the identified resource materials for the handbook during the upcoming conference cycle, 2006-2008. The WSC 2006 participants made a decision to give the World Board the authority to develop and approve these resource materials as addenda to the PR Handbook. This will allow the board to make these useful service materials available to trusted servants and other interested members of the fellowship in a timely manner.

The conference also approved the Public Relations Statement of Purpose for use by members and for their interactions with professionals and the public. This resource will be included in A Guide to World Services and A Guide to Local Services.



NAWS Efforts

NAWS continued to interact with professionals at various events and conferences worldwide to inform these professionals about NA and to maintain and cultivate professional relationships. We offer to provide professionals with knowledge of recovery literature resources; to listen to their concerns about issues, particularly what members say about medications; to dispel any misconceptions they may have about NA; and also to show them how to access the NA website for meeting information.

NAWS participated in conferences with drug court, correctional, and treatment professionals at the National Drug Court Professionals Conference, the American Jail and American Correctional conferences, and the National Association of Addiction Treatment Professionals Conference. We were invited to formally present in a workshop setting (information about the NA program) at the medical professionals' conference, American Society of Addiction Medicine.

The majority of these events were in the US; however, we did participate and formally present information at the International Conference of Addiction in Budapest, Hungary, and in a cooperative project with South Korea and Japan in Seoul. All these efforts contribute steps toward realizing our vision that Narcotics Anonymous has universal recognition and respect as a viable program of recovery.

In April 2006, during the public relations session at the conference, NAWS informed conference participants that we are willing to partner with regions and zones to further our public relations efforts. NAWS cannot attend all conferences, and we welcome collaboration with regions and zones. NAWS had the

good fortune of working with the Buckeye Region and with the Europeans at the European Conference Against Drugs which was held in Vilnius, Lithuania. At this conference we provided, through a presentation to the delegation composed of many government officials, information about Narcotics Anonymous. As we look toward the future, we seek to embrace another point of our vision: that NA communities worldwide and NA World Services work together in a spirit of unity and cooperation to carry our message of recovery.

Along with our collaborative efforts, NAWS recognized that with so many treatment and healthcare professionals who work with addicts and governmental agencies, we wanted to increase our presence at their conferences and to make them aware of NA as a credible community resource. These efforts help us to fulfill a third bullet point of our vision: that every addict in the world has the chance to experience our message in his or her own language and culture and find the opportunity for a new way of life. As more professionals become aware of our translated literature and the numerous countries where the NA Fellowship is thriving, they can truly appreciate the worldwide peer recovery network that so many of us experience. We are also a resource for them as they travel professionally and teach abroad. We recently assisted physicians traveling to Israel and Russia to find meetings and local contacts.

Issue Discussions

Throughout the fiscal year we had an opportunity to participate in zonal forums and workshops throughout the world. We took advantage of these opportunities to conduct sessions on the 2004-2006 Issue Discussion

Topics; Atmosphere of Recovery, Infrastructure, and Our Public Image. These sessions provided a vehicle for members from local NA communities to consider the issues and provide valuable feedback based on their experience with recovery and service. We used the information we collected from each session to guide our approach at sessions that followed. As a result, our sessions were able to grow and evolve each time we met with members in different places. These discussions consistently reflected an impressive level of depth and focus. Many thanks to all the members who participated so enthusiastically!

At the World Service Conference, we conducted final sessions on the cycle's Issue Discussion Topics. With the collective feedback from two years of discussion as their guide, participants confidently selected Issue Discussion Topics for the 2006-2008 conference cycle: Building Stronger Home Groups, Who Is Missing from Our Meetings and Why, and Our Service System. These topics flow directly out of the topics from the previous cycle. As a worldwide fellowship, we have come together to identify these as the issues that we must address in order to move closer to our vision. Each topic speaks directly to an element of our vision, and together we can find and implement solutions.

In the year ahead we will hold sessions on these new Issue Discussion Topics. The input we receive will continue to guide our conversations as we reach out to members around the world. Communities Around the World Welcome the Message

Translations and Fellowship Development

As of June 2005, NA spoke fifty-five languages. Over the following twelve months, that number grew to sixty-five. The process of translating the literature can be tedious and time-consuming, but the work does not stop there. One of the most crucial steps in the process is the evaluation of the conceptual fidelity of the translation. Essentially, this involves an assessment of the accuracy of the translations and whether or not the translations remain true to the core philosophy of the Narcotics Anonymous message. Of the nearly three hundred translation projects in the queue, we are actively working on almost eighty projects in more than forty languages. We have completed seventy-nine projects since the beginning of the fiscal year in the following languages:

One of our most long-awaited translation projects has been the Japanese Basic Text. After more than twenty years of effort, members in Japan have finally arrived at a translation of the Basic Text that they find satisfactory. They are now hard at work on *Just for Today*. Congratulations, Japan!

As we pointed out in the Project Updates section about Worldwide Workshops, we were able to take part in a Translation Workshop in Bangkok, Thailand, in conjunction with the Asia-Pacific Forum and Thailand Convention. More than thirty delegates and visitors from thirteen language communities registered and came to share their valuable experiences with



translations processes in their communities. At the time of the workshop, nine of those language groups had active translations committees, eight had published translated literature, and eleven had existing draft translations. Discussions about the challenges and solutions facing the translations process helped these members to share with each other about what works, and we were able to provide some use-

ful hints and tools to aid them in their future efforts. Participants identified a number of ideas about what should come next, including local translations workshops, a push for increased member participation in literature translation committees, development of LTC guidelines, interactions with other language groups, and increased efforts to

collaborate with each other and surrounding communities. Since our visit, communities have reported successful local workshops and revitalized support for translations efforts.

India is another of the countries that demonstrated increased translations efforts this year. There are sixteen main languages spoken throughout India, in addition to many others spoken locally and regionally. Through the course of this year, our translations team has provided active support to seven of those language groups. In February we traveled to Delhi, India, to finalize arrangements for the pro-

duction of keytags in multiple languages. We contracted for a substantial number of keytags to be produced in English, Hindi, Manipuri, and Bengali, in all denominations. When final local translations are approved, Tamil will be added as well. During this trip we also finalized a contract for warehouse space to store literature, keytags, and other merchandise for South Asian distribution. This was also an op-

portunity to attend the Delhi Area Convention held near Dehra Dun in the Himalayan foothills, and to meet with SIRSCONA (the primary Indian regional service committee) leadership.

Exciting developments have also been taking place in Africa in the last year. South Africa, which officially became the first seated region from the continent of Africa at this year's conference, has

also supported wide-scale outreach efforts to connect with addicts speaking languages such as Zulu, Xhosa, Southern Sotho, and Tswana. Draft translations in Afrikaans were also completed this year. Beyond South Africa, in more central and eastern parts of the continent, efforts have taken place to make progress with Swahili and Rwandan. We have high hopes about our message taking root on this great continent and spreading among those who really need it.



NAWS Responds to Members, Groups, and Your Service Communities

Your Fellowship Services

In order to support the many members, groups, and service committees involved in carrying our message to still-suffering addicts, our Fellowship Services team carried out the following tasks, among many others, throughout the fiscal year 2005-2006:

- Compiled and sent out more than 900 new group starter kits
- Responded to more than 4,500 H&I requests
- Answered nearly 9,000 telephone inquiries
- Responded to more than 6,300 emails and letters
- Responded to almost 650 miscellaneous requests, which this year included responding to the literature needs of Katrina-affected NA communities, including New Orleans, Baton Rouge, and Houston.

Fellowship Services also works hard to update and maintain the database. Information from group registrations or updates is typically entered into the database

within 2-4 days. Information generated by the meeting locator on the NA website reflects these changes including up-to-date meeting information. We encourage areas and regions to identify a Web contact—someone who can help to keep local meeting information current in the database. As of summer 2006, we had 124 members who were identified by areas and regions as Web contacts and remained actively involved in the process.

We also encourage areas and regions to send any locally developed resources (training and orientation materials, minutes, guidelines, etc.) to Fellowship Services

so that they may be made available to other service committees in need. Shortly after the end of the fiscal year, we activated an area on the website for locally developed service materials where local Web contacts can upload their materials to make them immediately available to other communities. This resource area is located at http://www.na.org/local_resource_area.htm.

Fellowship Publications

Among the other services provided in the 2005-2006 fiscal year, NA World Services continued to compile, produce, and distribute the major fellowship periodicals *The NA Way Magazine*, *Reaching Out*, and *Meeting by Mail*. The first two publications are made possible by the support of editorial workgroup members. We're grateful for their efforts to ensure the ongoing quality of these publications.

The NA Way Magazine saw another increase in standard-print subscriptions, from less than 37,000 to more than 39,000 copies in the first five languages. The first printing of The NA Way in Farsi in January was nearly 14,000 copies! We also took 7,000 copies of the English version with us to Hawaii for WCNA-31. Since the first time we published the magazine electronically in April 2005, the number of electronic subscriptions (e-subs) has jumped to nearly 3,000 from just over 400. E-subs reduce the distribution costs of the magazine greatly, in addition to being available in full color, and being more environmentally friendly. The NA Way Magazine is printed in six languages: English, French, German, Portuguese, Spanish, and, as of January 2006, Farsi. We re-

ceived about 150 submissions during this fiscal year, including essay/article manuscripts, photos, poetry, and illustrations.

One of our oldest publications, Reaching Out, remains a valuable resource, both for incarcerated members and for other members who are interested in Hospitals & Institutions service. The success of this publication depends on submissions from throughout the fellowship. While incarcerated members consistently send ample submissions, our "From the Outside" section suffers from insufficient participation. Members with H&I interest or experience are encouraged to participate by writing to share their experience, strength, and hope with each other and with members on the inside. We provide free single-copy yearly subscriptions to members who will be incarcerated for six months or more. We also provide, at a minimal cost, yearly twenty-copy subscriptions (for distribution to inmates) to members on the outside and service committees. Our printing for each issue of Reaching Out, generally around 9,000 copies, broke 10,000 for the first time at the end of 2005. The cover art for this periodical has been the same for nearly twenty years. It will soon undergo a facelift as we explore the possibility of featuring new cover art on each issue.

We send the *Meeting by Mail* to approximately 900 different addresses every other month. The purpose of this resource is to allow NA members to share in the process of recovery even when they cannot attend recovery meetings in person because of geographical isolation or physical infirmity. In addition to these "loner" members, many "nonloner" members participate. Subscribers can use the newsletter to share with one another their experience, strength, and hope as it relates to

recovery in isolation, and they can correspond with each other independently as they wish.

NAWS Communications

NAWS News provides an overview of world service activity, with an emphasis on World Board projects and activities. It is published following the World Service Conference and after each meeting of the World Board in English, French, German, Portuguese, and Spanish. NAWS News is distributed to conference participants and registered area and regional service committees. Individuals can also request copies of this periodical after each mailing, and it is available on our website.

The Conference Report, a comprehensive and detailed report of world service activity, is published before each World Service Conference. This report contains information regarding the status of major world services projects, suggestions for new work, and challenges that have been encountered. It includes reports from the World Board, Human Resources Panel, and any regional service committee or zonal forum that wishes to submit material. The Conference Report, published in English and Spanish, can be accessed on our website.

The Conference Agenda Report (CAR) is a tool for informing the NA Fellowship about the issues facing an upcoming conference. This is published and distributed in English a minimum of 150 days before the beginning of each World Service Conference, with translated versions in French, German, Portuguese, Spanish, and Swedish released a minimum of 120 days prior to the WSC. Members of the fellowship can use the CAR to engage in informed discussions in order to better understand the issues and provide the necessary feedback and decisions about conference

matters. The CAR is accessible free of charge on our website in an electronic format, and NAWS sends printed copies to conference participants and regions. Members can also order additional printed copies on the NA website.

The NAWS Annual Report provides a summary of world services activity for the prior fiscal year (July 1 through June 30). Once completed, it is distributed to conference participants and regions. Additional copies are available for purchase at cost from NAWS and can be viewed on or downloaded from our website.




Regions Around The World

Our Fellowship Comes Together to Celebrate Recovery

Your Conventions and Events Management Team

NA conventions, especially the world convention, help send the message that our new way of life in recovery can be fun and exciting. The enthusiasm and joy we share at these celebrations of recovery go a long way in enhancing the attractiveness of our message. The NAWS Conventions and Events Management team is responsible for planning a variety of annual and biennial projects that often require simultaneous attention. While the World Convention of Narcotics Anonymous and logistical support for the World Service Conference are this team's primary responsibilities, the team also plays a role in the planning and execution of many of our worldwide workshops. The team works hard to develop and maintain travel and housing relationships to accommodate our service and recovery events all around the world. The team also works to provide services to regional and area convention and event committees around the world, assisting with everything from contracts to committee structure and legal issues.

The World Convention of Narcotics Anonymous

Held early in the July 2005 to June 2006 fiscal year, WCNA-31 in Honolulu was a greater success in terms of attendance and finances than we expected. The convention exceeded our projections by about 2,000 people, with over 8,600 members registered and about 9,000 in attendance. We are immensely grateful for the assistance from the support committee, as well as the hundreds, if not thousands, of volunteers who help to make every world convention very special. From an operational perspective, the convention went very smoothly, the only exception being an incident between

a few members and several convention center personnel. While it is unfortunate that the acts of a few leave negative impressions of NA for some nonmembers, we are quite grateful that the convention went smoothly, especially in consideration of another challenge we faced. Two thousand members attended without preregistering and did not stay in official convention hotels, causing significant operational issues at the convention site because staff could not confidently anticipate their attendance. NA World Services operates on past convention projections as an indicator in order to try to make the most prudent use of valuable fellowship resources.

In preparation for San Antonio, we are making an effort to avoid similar issues by adjusting our approach. The pre-registration price, for example, will remain the same throughout the pre-registration period, instead of increasing when the convention approaches. The onsite registration price will also be significantly higher than the pre-registration price, both to encourage members to pre-register and to offset the costs of last-minute efforts to modify plans to accommodate larger crowds than expected. We are also encouraging members who plan to attend not to make multiple hotel reservations "just in case," only to cancel the extra reservations later. Doing so makes it difficult for other members to reserve rooms and for hotels to be properly prepared.

It is important to keep in mind that the purpose of the convention is to celebrate recovery, not generate revenue. The convention is an incredibly expensive endeavor. When those who participate pay their own way, as early as they can, the convention can be more successful and enjoyable for everyone involved. Early registration helps to keep the cost down for everyone, giving people the most "bang for their buck." This also makes it possible for all

of us to join together and send a message to newcomers and the general public: Recovery has given us a life worth celebrating!





This section of the *Annual Report* is broken into four parts: unit distribution trends, consolidated statement of financial position and consolidated statement of activities, independent auditors' report, and donations report.

The unit distribution trends report is a report of the numbers of inventory items distributed throughout the year. These numbers are presented in the form of charts and graphs that illustrate the number of books, booklets, IPs, keytags, chips, and medallions that were distributed by NA World Services during the fiscal year.

The consolidated statement of financial position (SoFP) and consolidated statement of activities (SoA), also known as the "balance sheet" and "income statement," provide a report of the financial activity of NA World Services during the fiscal year. The SoFP, or balance sheet, provides a simple breakdown of the current assets and liabilities of NA World Services in financial terms. The SoA, or income statement, provides a breakdown of the income and expenses for the following categories:



Under each set of expenses, we include costs for accounting, personnel, overhead, and technology. These are expenses that cannot be attributed directly to any of the specific areas of activity. They are budgeted and allocated (distributed) according to a calculated fixed percentage. This percentage is based on three factors: the number of personnel devoted to the activity, the approximate number of labor hours, and the amount of physical office space required by the activity. The percentages listed above indicate the budgeted amounts for this fiscal year (and for the two-year budget cycle).


The independent auditors' report is a report provided by an outside firm that conducts a professional audit of NA World Services' financial reports.

Finally, the donations report is a report of the donations received by NA World Services throughout the fiscal year from the NA Fellowship, broken down by region and/or country.


Where Does Our Money Come From?



Where Does Our Money Go?




Book Distribution 1983-2006





As you can see in the chart above, all-time Basic Text sales by the end of this fiscal year reached nearly six million, representing 67% of all-time recovery book sales. This year's Basic Text sales made up 52% of total book sales at 438,000 copies, a 38% increase over 2005 sales. This year saw the highest sales of the Basic Text ever, breaking even the record of the peak sales year of 1989, when 374,000 copies were sold. In 1999, sixteen years after initial publication, we reached the four million copies sold mark. Seven years later, we're poised to hit the six million copies sold mark. This means that more addicts than ever are getting the chance to read the NA message of recovery in a language they can understand.


Book Distribution 2005-2006




Booklet Distribution 2005-2006



Our two record years for booklet distribution (738,771 in 2005 and 735,914 in 1991) were far surpassed by this year's 951,118 recovery booklets. Total distribution of the White Booklet increased by nearly 100,000 pieces; it remains the most widely sold booklet, with a total distribution of 7,727,971 from 1983 through 30 June 2006. Total booklet distribution for this fiscal year showed an increase of 36%, which includes impressive numbers from Iran. Without Iran sales, booklets showed an increase of 6%. Six of the eight booklets are available in Iran, and these account for 22% of total booklet dispersal worldwide. Iran accounts for nearly half of total distribution of *The Group Booklet* and *NA*: A *Resource in Your Community*. Including distribution in Iran, the White Booklet showed an increase of 23%. Without the increased Iranian distribution, this would have been less than a 3% increase. Overall, booklet distribution continues to grow, but we're all very pleasantly surprised by how quickly the NA message is being embraced by members in the Iranian NA community.




Information Pamphlet Distribution 2005-2006



The distribution of IPs also demonstrates the impressive growth of NA in Iran. IP dispersal in Iran makes up for 26% worldwide, and worldwide distribution this year grew 30%. In Iran, only one of twenty-one IPs showed a decrease this year. Without Iran, total IP distribution shrank by nearly 4%, with eleven IPs showing a decrease. It's not difficult to imagine a time when distribution in Iran will account for more than half of the total worldwide distribution.




Medallion Distribution 2005-2006 18 Months & 1–25 Years




Unit Distribution Trends

Medallion Distribution 2005-2006 26-50 Years & Eternity




Chip Distribution 2005-2006

Supplemental disclosures of cash flow information: Interest paid during the years ended June 30, 2006 and 2005 amounted to \$157,142 and \$166,148, respectively.

Non-cash investing and financing activities: During the year ended June 30, 2006 and 2005, NAWS entered into lease obligations for the purchase of equipment in the amount of \$312,780 and \$655,090, respectively. NAWS also retired, without payment, lease obligations in the amount of \$98,144 during the year.

Notes to Consolidated Financial Statements

Independent Auditors' Report Years Ended June 2006 and 2005

Note I - Organization and Nature of Activities

Narcotics Anonymous World Services, Inc. (NAWS) was incorporated on 25 January 1977 and is headquartered in Chatsworth, California. In addition, NAWS operates a literature distribution facility in Toronto, Canada and an office in Brussels, Belgium*. NAWS is a not-for-profit organization which provides communications and information for the Fellowship of Narcotics Anonymous (NA). NAWS achieves its purpose by maintaining correspondence with NA groups and service committees, by printing and distributing World Services Conference (WSC) approved literature, and by maintaining the archives and files of NA.

In 1993, NA established the Fellowship Intellectual Property Trust (the Trust). The Trust was established for the purpose of holding and administering all recovery material and other intellectual properties of NA. The Trust is included in the consolidated financial statements of NAWS as a result of common control.

NAWS is exempt under Section 501(c)(3) of the Internal Revenue Code and comparable California Revenue and Taxation Code. The Trust is also exempt under the applicable Internal Revenue Code and comparable California Revenue and Taxation Code. In addition, the Internal Revenue Service has determined that the organization is not a private foundation within the meaning of Section 509(a) of the Internal Revenue Code. Therefore, no provision for Federal and state income taxes was made for either NAWS or the Trust.

Note 2 - Summary of Significant Accounting Policies

A. Consolidation Policy and Basis of Accounting

The accompanying consolidated financial statements include the accounts of NAWS and the Trust. Significant intercompany balances and transactions are eliminated in consolidation. The consolidated financial statements are prepared on the accrual basis of accounting.

B. Financial Statement Presentation

Under Statement of Financial Accounting Standards No. 117, NAWS is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets and permanently restricted net assets. As of 30 June 2006 and 2005, NAWS held no temporarily or permanently restricted net assets.

^{*} Although reported in NAWS consolidated financial statements, our branch office in Tehran, Iran was inadvertently omitted from the auditors' notes.

C. Cash and Cash Equivalents

NAWS considers all funds held in checking and savings accounts to be cash and cash equivalents.

D. Investments

NAWS investments are carried at fair value which generally represents quoted market price as of the last business day of the year. The certificates of deposit are valued at cost, which approximates fair value.

E. Publication Inventory

Publications and other items for resale are included in inventories and are carried at the lower of cost or market, with cost determined by the first-in, first-out method.

F. Property and Equipment

Leasehold improvements and furniture and equipment are stated at cost. Major additions are capitalized while replacements, maintenance and repairs, which do not improve or extend the useful life of the asset, are expensed. Depreciation is computed using the straight-line method over the estimated useful lives of the related assets, which are as follows:

Leasehold improvements

5 vears

Furniture and equipment

5-10 years

Depreciation expense for the years ended 30 June 2006 and 2005 amounted to \$340,264 and \$212,902, respectively.

G. Trademarks and Copyrights

The cost of acquiring and defending copyrights and trademarks is capitalized and is being amortized over the approximate economic life of the copyright or trademark, which is estimated to be ten years. The cost of computer software is also capitalized and amortized over a period of seven years. Amortization expense for the years ended 30 June 2006 and 2005 amounted to \$120,651 and \$113,936, respectively.

H. Accounts Receivable and Allowance for Doubtful Accounts

Accounts receivable are reported net of an allowance for doubtful accounts. The allowance is based on management's estimate of the amount of receivables that will actually be collected. Management estimates uncollectible accounts based on the age of the receivable and other factors.

I. Translation of Foreign Financial Statements

Financial operations in Canada and Europe are translated throughout the year to United States dollars. Gains or losses resulting from translating foreign currency financial statements are recorded in the consolidated statements of activities.

J. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Note 3 – Retirement Plan

NAWS maintains a qualified defined contribution retirement plan, which covers all employees. Under the terms of the plan, employees may elect to contribute pre-tax earnings up to the maximum allowable amount. NAWS matches up to 5% of the deferred earnings based on the employee's number of years of service. The matching contribution to the plan for the years ended June 30, 2006 and 2005 was \$59,435 and \$46,541, respectively.

Note 4 - Operating and Capital Leases

NAWS has entered into capital lease agreements for the use of telephone and office equipment. The total value of the equipment under capital leases is \$901,304. NAWS also leases equipment and facilities under various operating leases. Minimum future lease payments on noncancelable lease commitments, including interest on capital leases, subsequent to June 30, 2006 are as follows:

NAWS places its cash and cash equivalents with high quality financial institutions. From time to time, the balance exceeds the Federal Deposit Insurance Corporation insurance limit.

Note 7 – Employment Contract

NAWS has entered into an employment agreement with its Executive Director for employment services. The agreement provides for compensation and benefits and expires on 31 December 2009. Should the agreement be terminated by NAWS certain amounts would be payable to the Executive Director as defined in the agreement.
