




## **Goals And Purposes**

## Separation

The question of why was there a separation between the Core Group, Host Committee, and Planning Committee has been asked. Since the question is being asked we feel it needs to be answered. The first fact that needs to be clarified is that the Planning Committee was never a part of the Core Group.

The Planning Committee was formed after a group of individuals who were on the Core Group decided to leave the Core and align themselves with the Host Committee who declared themselves autonomous and not accountable to the Core Group. This action occurred when a vote was being taken and the host committee decided that they would not wait for the vote and acted on self-will. This type of action is the same action that our service system has been doing for years and purpose of forming a USSC was to prevent this from happening.

When the Core Group asked the Host Committee if they were autonomous, they said yes. That action told the Core Group that they (the Host Committee) had separated themselves from the Core. Within that week some members of the Core Group choose to form the Planning Committee and align themselves with the Host Committee that declared autonomy and separate themselves from the Core Group and their core values of group conscious. 95% of the original group members are still on the Core Group who never went anywhere.

The Core Group holds on to its goal of helping to form a USSC based on group conscious and serving the fellowship through a conference of the regions (USSC) of the USA using the 9<sup>th</sup> Tradition and its Inverted Pyramid that makes the member the most important person in the fellowship. Through this process the day again will come when a home group can make a motion and change what can happen in the US Fellowship by that motion having the opportunity to be group conscious by all groups in the USA. The Core Groups maintains its original core values and plans to continue to have Fellowship Assemblies in the future as well as workshops. 

## Summary of Core Group Project Discussions for the Month of June 2013

#### Week of June 4, 2013:

- Brian talked about NA Membership being a privilege and the rights of membership.
- Bo talked about his trip to New Orleans and the energy he felt there and how we need to take what we have learned in the last 2 years and re – invent the Core Group.
- Brian talked about how there are those with 30 year old resentments and the need to learn surrender and then there are those who want to cut the purse strings to WSO and how their job role should be literature distribution and collecting and broadcasting information to the fellowship.
- Bo mentioned that having the opportunity to engage in positive discussions and exchange information in a loving manner is what gives us new life.

#### Week of June 11, 2013:

- Kelvin from Louisiana joined the Core Group.
- Jmu discussed the needs for a National Helpline.
- Kelvin mentioned that we had developed a core to repair the disconnect with National Services such as H&I, Helpline etc.
- Jmu stated that it just wasn't happening. He said that World decided that Subcommittees were not working and tried to reorganize them and then went over to Business and Public Relations instead of Public Information.
- Lester commented that his area is looking to break away from the Florida Region and one of the possible outcomes that we are looking at is to become an independent area.
- Jmu mentioned that he had learned about a Basic Meeting Finder that was easily downloaded and when you typed in the zip code it found your meetings right away,
- Lester commented that the BMLT (Basic Meeting List Toolbox) had been out for some time now and that the Florida Region uses it. One of its problems is that areas are not automatically listed with it. If an area wishes to be added to it they have to install it locally so they can get on the Regional list. Many areas have chosen not to do this and therefore their meetings are not listed.
- Kelvin asked Lester why area wanted to break away.
- Jmu commented that the Service Structure is not serving the fellowship the way it might and that members are looking for ways to do service...
- Lester commented that the Florida Region has become the poster child for the SSP and now operates entirely on CBDM (Consensus Based Decision Making and that our RCM is now a mute position since very little comes back to the Region to be voted on. Under

- CBDM if 10 Area's each submitted a motion to Region to forward to World Services. All motions would be discussed on the regional Floor and the top three would be picked and sent to a workgroup to be workshoped. And after the motioned was workshoped at the Regions digression the motion would either be stopped or sent back to the groups in its newly rewritten form to be voted on as to whether or not send it on to world. Basically our groups and areas no longer have any say at region. Since all motions are discussed and for the most part dispensed with on the floor of Region.
- David came on conference call and Jmu was talking about core group and why we are doing this.
- David Conclusive to group purposes, more creative, more spirit and freedom. Don't need all the rules. Thrive in non-structural service. Some members can't deal with non-structural.
- Bo stated that we don't need all the structural boundaries. We are trying to form NA Society and inform members including writing study material.
- Lester said that his area had looked at the SSP and what is happening within our fellowship and we came to conclusion that WB members hit nail on head when they said the SSP was a done deal whether we like it or not.
- Jmu asked," Is that good or bad?"
- Lester replied that FRCNA is poster child for SSP and our groups no longer have a voice. Our RCM are being asked to vote for us a, not in our behalf.
- David is more optimistic about our core group efforts. Members say it is too complicated and don't like World telling them how to form their boundaries. Members actively seeking information. They're waking up.
- Kelvin commented, "our RD's have lost the concept of their position." Need to get back to members down service instead of dictating.
- David you have members brainwashed into believe they should accept being talked down to by servants. Delegated to represent and make decisions without representing group. Admins don't have right to decide what information should be passed on to local Fellowship.
- Kelvin Reading Living Clean now. Elaborating on Basic Text info. Need BT more than LC. Thinks the writers of LC are just expounding on BT. Don't need servants to think they are in positions of authority. Doesn't know many members in WS. Structure needs to be in tune with our message.
- Lester agreed to do Newsletter?
- David need to represent good articles like ABCD and our archives

- Bo this is the leading edge of Global NA. It is re-connecting the Fellowship. Lester the more people see it and like it, the more areas will follow suit.



## **Personal Opinions:**

Recently a friend of mine asked me,"What was the Definition of a Purist. I did not hear much about the Purist Movement on the West Coast when I got clean in 1986. My personal belief is that running Newcomers away from NA is not NA nor is scolding those who do attend other fellowships. I learned to use NA language very quickly out of respect for my when at my home group as well as having a few addict explain the reasons we use NA language after the meeting in a very loving and caring way. This is not what NA is about. I easily identified as an addict and found it to be inclusive. NA is about Living a Program of Attraction and total abstinence from all Drugs including the Drug Alcohol.

This invited me to do some research. So I went to "The Traditions War" for a broader perspective. Here are some excerpts.

"Recovery in NA was just a dream for most of us. Yea, man that would be cool to have NA every night. Someday. ."

Something that the key players in the Lit movement understood was that you had to bet your life on NA or no one else would! They began to become adamant about this stand and would leave these Lit conferences and NA conventions where they met up with each other to get pumped up, then would go back to their small NA communities and with excitement they had gained by being around other like minded folks, would push the new message of one disease and one program to all the poor unsuspecting drunks and junkies back home.

Back then, they came up with the name **S.W.A.T** which stood for Service Workers Attack Team! **This was really the first organized, named purist group.** They even made up t-shirts for you collector types. In discussions with the spiritual leader of the literature movement, Greg Pierce (deceased), several of the members he sponsored wanted to come up with a name and purpose other than SWAT. The discussion came around to a simple card and a simple name and a simple purpose. Greg said to me; "You don't wanna know what it started as. smile!" I guess he toned it down a bit. It was called **Anonymi,** and it was simply a printed blue calling card that said: (I apologize, I can't find mine so I will do as best I can, and hope someone will edit it correctly) **"A worldwide NA home group who's trusted servants gather to gain the love and support they need to continue carrying the message in their home groups and areas.** It's primary purpose is to disband."

A world-wide NA Home Group designed to provide our trusted servants (whose service has sometimes isolated them from their local groups) with the love and understanding they need to survive.

So the purist movement was actually made up mostly of sons and daughters of Anonymi and SWAT. With a few original members in the mix. The seeds of the movement were firmly planted at a late night rap session in Washington, DC prior to the WCNA 14 Miracles Happen convention in Chicago September, 1984. It was during this year that DC had a fund raiser for their bid committee. The cool thing about NA was that all the opposing bid committees showed up to support them, Virginia, Pennsylvania etc. They were so moved by this, as their turn out from the local fellowship was a bit weak and our coming to support them made the event a success.

Late night Saturday, a bunch of us Anonymi's/Convention/Service friends were gathered in a room at Georgetown University were the event was being held. We jokingly began talking about the do's and don'ts of being a purist. The word had been floating around for a few months by now. It came out of an article that the guy Jim M from Ohio had written for an early NA way magazine entitled "The unfolding of the fellowship". It asked "what about those folks that only go to NA meetings for their recovery and identify themselves simply as addicts. Are these folks radicals? No they are merely purists".

In our late night talk session, we came up with 24 do's and don'ts to be a purist. Some was for fun; some we truly believed in our hearts was the right thing and the only true future for NA.

Jimmy D was at that meeting that night and felt inspired to go home and create. He came up with a simple purple bandana and a folded up little news letter called the Purist News volume 1; Jimmy says he had the bandana at Chicago. I know that the Newsletter was distributed at the 6th East Coast Convention held at Towson State University, Towson, Maryland in June of 1985, just prior to the World which was being held right next door in DC in September, 1985. Jimmy gave me a copy of the Purist News and like the rest of the gang; I went home and copied it like mad! It became our manifesto. It was the first thing in written form that spelled out what it was that had become imbedded in our hearts and minds for a long time now.

March 27th, 1985 Qualifications for a "PURIST"

- #1) Identify themselves as "ADDICTS".
- #2) Sustain their Recovery by attending N.A. Meetings.
- #3) Would prefer to travel 50 miles to get to an N.A meeting than go to any other fellowship meeting.
- #4) Consider their membership in N.A. the most important thing in their life since their very life depends on N.A.
- #5) Live by the Principles of the 12 Steps & 12 Traditions of N.A.
- #6) Speak the language of N.A. (Being clean, not sober; accumulate clean time, not sobriety).
- #7) Refer to our book as the "Basic Text" not the big book.
- #8) Do not refer to the people they sponsor as "pigeons".
- #9) Quote our "Basic Text" Not any other fellowship books.

- #10) Are active members on the Group, Area, Region, and World levels.
- #11) Take their service commitments seriously and try to the best of their ability to carry them out.
- #12) Attend and support all N.A. functions first before any other functions.
- #13) Carry the message of N.A. Recovery, which is undiluted by any other message.
- #14) Understands that N.A. is a unique and separate fellowship that offers recovery from addiction.
- **#15) Helps Newcomers**
- A) Explains the meaning of the first step of N.A.
- B) Explains the concept of Anonymity.
- C) Shares and cares the N.A. way.
- D) Encourages involvement in N.A. meetings and other N.A. functions.
- E) Takes new members to meetings where the N.A. message is found.
- #16) Cares enough about the future of N.A. to get up and do something about it.
- #17) Considers it a privilege to serve the fellowship.
- #18) Upholds the traditions of N.A. in their Groups, Areas, and Regions.
- #19) Speaks up when traditions are being violated even when it brings criticism or resentment from non-purist members.
- #20) Realizes that their personal recovery is based on N.A. unity... and that N.A. must remain pure to insure its survival.
- #21) Realizes that our group conscience never goes against the traditions and that there is a difference between "group conscience" and "group opinion".
- #22Are usually misunderstood and/or disliked by non-purist members, but believe in their hearts that it is better to follow what they believe is best for the fellowship of N.A. than it is to please some members.
- #23) Share a strong common bond with other purist members and often go to great lengths to seek out other members who consider themselves "purists".
- #24) And perhaps, most important... Purists give warm loving hugs... The N.A. Way

## **Recovering Purist:**

# From a recovering purist

#### **MAY 1987**

I am an addict, and one of the problems I have as an addict is interacting with other people. There are two personalities inside me: The spiritual recovering person and the diseased addict person. I can be compassionate, understanding and nurturing. I can also be insensitive, obnoxious and judgmental.

How well I am working the N.A. program is what determines my words and my actions. I have learned to check my motives, and I try to keep in my mind to seek to understand rather than to be understood.

In my love for and pride in N.A., I have been a big pain in some of our members' behinds. In dealing with what I have considered tradition violations, and in differences about opinion of N.A. philosophies, I have been confrontive, agonizingly persistent and overbearing.

At these times I considered myself vigilant and concerned about the wellbeing of N.A. as a whole. Looking back now, I can see that I was self-righteous and radical. This letter is not a confession or admission of guilt, it is simply the truth as I see it today. Hindsight is 20/20.

have calmed down a lot, much to the dismay of some of my radical friends. My beliefs have not changed, but my methods have become refined. I have found that tact and diplomacy work much better than threats and antagonistic confrontation. I have learned these lessons painfully by making many mistakes and some enemies within our fellowship.

I still believe in carrying a pure, undiluted N.A. message, I believe in using N.A. language, I believe in the concept of "one disease—one program," and I believe that N.A. is the only place I need to go for my recovery.

Today, however, I am willing to let other members have their own opinion. I still cringe when I hear someone in an N.A. meeting talking about their "sobriety" or about their gratitude to another fellowship, but I do not verbally take their inventory during the meeting nor do I tell them after the meeting that if they can't share the N.A. way then please do not come back. I have done both of these things in the past.

Today, I do not have to "protect" N.A. from anyone. I am not responsible for what anyone says at a meeting. At one point in my recovery, if someone said that they needed to go to another fellowship for any reason, I would give a number of reasons why I did not need to go anywhere but N.A. for my recovery. I would not allow any newcomer to leave any N.A. meeting that I was at thinking that they had two diseases or that they needed

anything else but N.A. to recover. I could be brutal in my sharing and I often was.

When I first got wrapped up in this "purist movement," it was at a time when there were very few N.A. mem-

bers that I knew about who only went to N.A. for their recovery. None of these members were near me. There were only two N.A. meetings in my area when I first came around, and I helped start three more within the next year. I was going to all five of them and traveling around the state going to others.

I knew that I did not need to go anywhere else but N.A., but no one else in my area believed that they could. For me, making that decision to go only to N.A. when no one else believed in it was very scary.

n my fear I became very proud and very self-righteous. I became extremely outspoken about N.A. and extremely critical of other members who went to the meetings of other fellowships.

I intentionally tried and in a few cases succeeded in driving certain "cross-addicted" and "sober" N.A. members out of N.A. I don't feel good about the way I acted but I am not sorry for what I did. I did what I did because I thought it was for the good of N.A. I do not know where those addicts are now; I hope that they are

still clean and recovering somewhere. I designed the "purist" T-shirts and bandanas. I had them printed up and sold them at conventions. I printed the Purist Newsletter and the ODOP (One Disease, One Program) newsletter.

I did these things because at the time I needed to do them for my recovery. I did these things because I thought that they needed to get done. Somebody had to stand up for N.A. and this was my way of doing it. Thank God that I don't have to do these things anymore!

oday I can be a member of N.A. instead of being one of the "guardians of our traditions." My message hasn't changed; the way I share it has. I find that my message is much more accepted when I share it in a loving and caring way.

I don't waste my time trying to get anyone to do things or to say things that I consider are the N.A. way of doing and saving things. I share my experience before, during and after meetings with whoever will listen to me. I try to focus on newcomers.

The purist movement is not over, and it will never be over. There will always be newcomers, fresh out of rehabs talking all the "cross addicted" language and concepts that they were taught in rehab. They don't know any

better, and it is our responsibility as N.A. members to share with them about N.A. language, N.A. philosophy and N.A. recovery.

There will always be members from other fellowships who will find their way into N.A. They will be using terminology from whatever fellowships they come from and they don't know any better either. It is our job as N.A. members to share with them about N.A. and our program of re-

don't need to write purist newsletters anymore because I can write for the N.A. Way and our other fellowship newsletters. My articles are often viewed as antagonistic, and I am working on that.


anymore because it doesn't help anyone; it only creates disunity within our fellowship. I do not intentionally try to drive anyone out of N.A. for any reason today. I am trying to accept all of our members as they are-as recovering addicts just like me.

other N.A. purists throughout the world, because without them I doubt that I would be clean today. Without

their love and support, N.A. here in my hometown would not be where it is today. We have grown from two meetings per week to twenty-three meetings per week. I am grateful to be a part of the growth of N.A.

here are eight thousand N.A. meetings in the world today [written in May 1987-two years later, there are almost sixteen thousand]; when I got clean there were less than one thousand. Chances are that many of those who are reading this article got clean in a local N.A. community that was started by a purist, someone who believed in N.A. and was willing to go through the pain of keeping it alive when other recovering addicts were

There is nothing wrong with being a purist if you are one, and there is nothing wrong with going to other fellowships for recovery if that is what you choose to do. There is no right or



wrong when it comes to N.A. membership. We are all N.A. members and we are all equal. It took me a long time to realize that we all belong here regardless of how we identify ourselves or what terminology we use.

As we grow in recovery and in our understanding of the N.A. program, most members find themselves using N.A. language because that is what is most appropriate. We learn to separate the different messages that we carry and when we are in an N.A. meeting, we carry the N.A. message only. It is so simple to understand when we become open-minded. It is a matter of personal awareness and growth.


t is also easy to understand that none of us has the right to intimidate or criticize any other member. I understand this very well today. When I am sharing with other members about language or traditions, I keep in mind that no member ever intentionally tries to harm the fellowship. I really try to understand where this member is coming from and I share in the most loving and caring way that I can.

I have grown a lot since those first purist T-shirts made their debut in Chicago at WCNA-14, and so have many of us who call ourselves purists. We have been blessed (or cursed) with the burning desire to help N.A. grow. Sometimes our methods are wrong. but our motives are not. We are human and we are recovering addicts.

I have no regrets about the past, only hope for the future, and I intend to keep the N.A. message alive, pure and undiluted, just for today, where

#### Comment: Motion passed and was implemented

Motion 75 amended Resolution B by stating that the world Board should include a group to serve the original purpose of the WSB i.e. guardians of the tradition

Comment: Amendment was Implemented but later disbanded.

- Motion to vote on amendments C through G as they appeared in the CAR and refer all amendments to the Transition Group.
- Passsed.

#### Resolution C1

To approve *in principle* the elimination of standing Committees.

#### Comment; This Motion was (Defeated) but was later fully implanted.

Resolution C2 (To approve *in principle* a significantly downsized standing committee structure responsible to the World Board.

#### Comment: This Motion Passed but C1 was implemented instead of C2

#### Resolution D

To approve *in principle* the adoption of an ad - hoc committee structure responsible to the World Board.

## Comment: This motion was Defeated but is now the type of Structure that we have and are moving towards.

#### Resolution E

To approve in principle the adoption of a unified budget encompassing all world service funds.

#### Comment: This motion Passed and has been implemented.

#### Resolution F

To approve *in principle* the adoption of a World Pool of experienced trusted servants as a resource to world service projects and initiatives.

#### Resolution G

To approve *in principle* the adoption of a Human Resources Panel as a means by which the WSC may choose trusted servants based on the willingness to serve, experience, and knowledge.

As one can plainly see, on several of the Resolutions they went against Group Conscience, especially with motions C1,C2, D, and the amendment to Motion B.

Motion A called for a fellowship review of 5 options. It was later decided to allow this to occur in a natural process. This was 17 years ago and the review never happened and now we have the SSP.
