





Can lead to manipulation vs. bringing full control back to members. Underlying ego trip. Discussed w/sponsor. Should she do letter to group members? Interest in young females...

Tim - inform group, read literature.

Jmu - Has great Home Group. Lots of mutual respect. Write brief letter: "I'm leaving and why."

Tim - likes that...

Monica - Group is stagnant, she is miserable. Tried to talk directly. Not a black and white program, many shades of grey. Feels shut down. Any group motions shut down. Fear of group pressure and individual pressure for free expression.

John F - Lots of members looking for softer, easier way. Under value the 12 Traditions. Anyone who disagrees gets destroyed. Don't want to hear anyone with clean time. He has tried everything, even started X Anonymous at Texas Roadhouse and offers of free steak. Meetings 'go dark' meaning door is locked. Sometimes sign on door '12x12' and anyone with key can open and have meeting. Fellowship east of Mississippi is whole different case. In Missouri, whole room will jump on him, scream at him.

Bo S. - We discuss and deal with messy business. Had great weekend with Chubbs from North Carolina and a couple, Jessica and Eddie, from Dawsonville. We worked on stories while Eddie looked up talks by Greg Pierce for planned book to be transcribed. Checked out new voice recognition software, Dragon.

Chubbs - not comfortable with making video clips. 11th Tradition.

Bo – Well, you can always talk and not show your face and still participate. The important thing is to share feelings as well as words and your voice does that. People need to know it's real people sharing. Let us know if you come up with something to help us understand your concerns.

Weekend of 19th to 22nd went like a nice, spiritual dreamscape! Running a little ragged, headed for Michigan Sponsorship Gathering Friday!

John – had a quiet weekend...

Lester – Got angry call from Arizona riled up about Global NA effort.

Bo – Hank got call from same guy, apparently taken from FB contact information. Hank said he didn't think he would get another call! Anger is an empowering emotion.

Mitch – has all the speaker tapes from Stamford History, will share. Bonnie drove up and they attended together. John Farrell was a good speaker. Said Bob R was on one side, Larry N. the other and he was in the middle!

Lester – John has his own bones to pick with NAWS.

Mitch – John F didn't like deletions in Traditions 4 and 9 from printing of First Edition Basic Text.

George R spoke with great passion. Bonnie gave great talk. Karen B from California was funny and told story of being 'black listed' from speaking at World Convention of NA one year because she had gone to some AA, then called to speak at a later WCNA as kind of an amends but she had to care for her aged Mother. Fawn spoke Sunday morning.,

Mitch – Spoke with Mel H who likes Global NA. Found one of best friends is Jack B. who he holds in high regard.

Lester – Chuck Skinner was my first sponsor, same as Bo.

Mitch – Did Bob Rehmar, Jimmy Kinnon and Chuck Skinner sign off on 4th and 9th deletions?

Bo – Changes were made because they thought WSO could not service the Fellowship with "all else is not NA" and the service boards "do not have the power to rule, censor, dictate or decide" for the Fellowship. All three seemed to not understand what the big upset was about. From my position on the Lit Committee and later on the World Service Board of Trustees, I could see quite clearly the Fellowship and active members of the World Service Conference knew that Chuck, Jimmy and Bob all had six months to bring up any problem with the Basic Text as approved by the Fellowship and Lit workers. If they found a serious concern, like they say they did in some writings and talks, the proper thing would be to notify the Fellowship and proceed with caution for not catching it during the six months they were to review the material. It wasn't buried in an obscure part of the Book where it was hard to locate. It was right there in the Traditions. This should be a lasting lesson about the weakness of making hasty decisions without checking with other members knowledgeable on a topic or issue. Instead we had one of the safeguards of the Twelve Traditions removed amidst confusion that endures to this day. Another thing, is lofty service positions can make members think they know best. I have found this is usually a mistake. Informing and maintaining a high level of information disbursement is the basis for coherent action spread over a large body of people.

Mitch – So much hell raised about the 1st Edition BT, The so-called letter from Nebraska reads like a lawyer wrote it. Dutch H, active in H&I, wanted a low cost BT to go into jails where hard backs were not allowed. The soft cover produced by WSO is same size as BT hard cover and costs the same. Larry North could have played a role in this. [note: I follow a convention that says last initial on living persons, full name on deceased for clarity to the reader.]

Bo – Propose Mitch and I do a write up and run it by John and Lester prior to putting out to the core group.

John – Fellowship got up in arms enough for WSO to make a 2^{nd} Edition. Kermit says Fellowship confused by language sent out to Regions at the time where they made reference to the 1^{st} Edition as if it were the "Original" approved by the Fellowship after having each group in the world look over their own approval form of the Basic Text – the soft cover with a white shiny cover and the folded 8.5 by 5.5"

Mitch – Bobby B in hospital for tests. Gave Bo the number to call. Been feeling disoriented lately, like there is widespread disrespect for old-timers in Baltimore.

Bob McK. Celebrates 40 years!!! Yea!

Bo – So, let's review the tape for all the things I covered in the long forty minute talk on book changes, ok?

Instead we had one of the safeguards of the Twelve Traditions removed amidst confusion that endures to this day. Another thing, is lofty service positions can make members think they know best. I have found this is usually a mistake. Informing and maintaining a high level of

I think it is evidence we are here to serve.

Lester – Has twenty-five meetings in his area. If he was to bring home chips, most would stick it in their pocket and forget about it. Majority would say groups are working fine, why fix it? One group is already making out lit. Half the cost of what lit would be at area. Not really about the money, don't want to give money to NAWS.

Mitch – Letter from NAWS about groups publishing and refer to the subject as 'illicit publication and distribution.' They asserted it was example of going around the Traditions. Lester – Sending cease and desist letters to individuals, not groups.

Bringing attention to this only led me to be lied about and slandered later. We are moving away from the simplicity of service and recovery and finding ourselves in murky water. As we are told we need to be all things to all people, we are losing ourselves. 
Bo - People can project on possible violation while the reality is not so bad.

They don't want to contribute time and money to a system with a dozen holes in it. First thing we learned three years ago is there is a 'disconnect' between world service and the general Fellowship. Recently, it has come to light that with the Federal Government having a vested interest in a popular new drug called Suboxone, requires treatment centers getting Federal money have to offer Suboxone therapy. This means certain book publishers will stop ordering recovery books stressing total abstinence. When this happens, WSO will lose book sales. They will seek to continue the cash stream. That's one side. The other is having court judges populating our meetings. Drug dealers, gang members, teenagers drinking beer. This is what moves us to actively develop a new service structure, while we can. Lower costs, decentralized structure, simple voting methods, restoration of our representative service bodies and the guardians of our Twelve Traditions. 

Global Service Structure - Provisional

Way back when we had no written service structure and only twenty known meetings in the world, a fellow who came to NA in a business suit took it upon himself to write the NA Tree, our first service structure. The NA Tree outlined a structure to suit the special spiritual needs of Narcotics Anonymous. A structure designates the primary service bodies which compose the system by which a membership functions to co-operate for the benefit of all. It also describes and defines how and when they interact to satisfy the needs of the membership.

At the top is the Member, the basis of all of NA. All the functions of our formal service structure are performed by members; they write down things they hear or think of in the atmosphere of recovery we find in our meetings. This is their literature They write down meeting lists if they need to. They carry our message so addicts can find our meetings. This is their public information to let people know where the meetings are and when they meet. They attend our meetings and they alone can start new groups and meetings. They carry a message of hope to the newcomer and carry the experience, strength and hope accumulated within the Fellowship of Narcotics Anonymous.

Groups which hold one or more meetings a week are just below the Member in importance. Members read and study to learn the special NA way of doing things. They show up, lay out the literature and put on the coffee. They make sure the meetings start and finish on time. This is to protect the right of members to keep their commitments away from meetings whether it is getting home for a spouse, a baby sitter or their jobs. A chairperson is usually chosen on a monthly basis and a discussion leader starts off the meeting with a few words and a topic of discussion. There are also speaker meetings, participation style meetings, table meetings and other formats described in the course of opening the meetings along with a prayer and readings from our literature. We include these readings in each meeting so as to drive home certain things necessary to recovery involving how we treat one another and our duties and responsibilities as group members.

Each group sends a Group Service Representative to the local Area Service Committee to find out how other meetings are doing, get group supplies and help communicate with the other meetings. Some groups have an alternate GSR ALT (Group Service Representative Alternate) to

train to step up to the position or act in place of the GSR if unable to attend.

The Area Service Committee (ASC) is composed of group representatives who share resources to benefit local group needs and participate in discussions that determine how those resources are allocated for routine and special services provided with group resources. The ASC has the usual complement of Chair, Vice-Chair, Secretary and Treasurer along with Sub-Committees, each with its own Chair and Vice-Chair. The Vice-Chair position is important to maintain the direction and services to which their sub-committee is devoted. The most important people in the room are those who carry their groups conscience. They do this by keeping their group members informed and listening carefully to their reactions. One of the difficulties addicts face is no one takes them seriously because of the damage done. When they realize they are taken seriously, they wake up. They are energized. When they feel their concerns and issues are corrected or implemented, they become more responsible. Learning days teach newer members and remind older members how things are done within the 12 Traditions of NA. When members or service bodies disregard our Traditions, insanity and disunity result.

Learning is the only way of maintaining our integrity and commitment to pass on to others what was so freely given us when we got clean. How to chair a meeting, how the service positions work together to produce the miracle of NA recovery. When this system is disconnected from group conscience, service stops working and floats off on a cloud of ego. Service necessarily must be, attractive, approachable and transparent to transmit hope to those who would save lives through their efforts to serve our Higher Power.

Ways to enable the groups to carry the message...literature in probation offices, suboxone, clinics, drug court offices, and presentations to all of those previously mentioned...An effective and low cost virtual Hotline to involve members in...Books in all Libraries, meetings schedules and Posters in areas targeted by the groups through their GSRs or representative if no GSR is present, Outreach members to contact isolated groups and members to determine their needs. Also design website templates that can be used by even the uneducated on websites. Also business cards to give out durable phone numbers or meeting places. The main purpose of an ASC is to enable to use our funds responsibly by "two living cheaper than one." They may buy blocks of website hosting from a company like www.godaddy.com Literature printing like ips and posters. Each Area sends a representative to their Regional Service Committee (RSC) which has the same officers as it component areas.

The Regional Committee pools resources and provides routine and special services for its member areas, groups and members. Many members believe the honor and responsibilities

that go with group, area and regional services enhances membership and recovery so long as faith is kept and spiritual condition is maintained. The RSR (Regional Service Representative) carries group conscience which came from members, groups and areas to the National Service Committee which combines the resources of the Fellowship to provide routine and special services such as national help line, public information, H&I, activities, and literature.

Any number of regional committees may be formed to provide adequate communications and the array of services to help our membership get together for discussion and decision making. As with the areas and regions, a National Committee may be required to help establish and maintain services. In some continents this helps where there are unique cultural and language differences.


The Global Service Committee allows all members and their representatives to come together to attend to the business of NA. To prevent excessive concentration of money, power or prestige in one great over body, the main item is discussion of mutual concerns and resources to better service the general Fellowship. A system of service centers replaces the cumbersome rigamarole of treating with members as if they were part of a management system or a mercantile group. Paid personal is used only for performance of routines under direction of members and their service bodies.

The SSS gets away from the idea that our groups and members need someone or something to tell them what to do.



If you have given all that you had, only wanting love, understanding, acceptance and appreciation in return but getting nothing in return, you would not understand.


If you have never woke each day and begged the God of your understanding to reveal to you, your place in this world and received not one ounce of response, you would not understand.
