Important items from last five years.

- 1. USSC Vito asked for plan of action. A gathering of members showed up at Wichita for Fellowship Assembly One. An Informational Book was constructed to put writings to help attending members understand to situation we face. The main result was a good set of minutes and the general idea of a "disconnect" between the general membership and world services. Nobody seems to realize that there was no announced 'us and them' until the Basic Text was written with those who supported or participated in the writing on one side and those who did not on the other. In general 'us' is still alive and well in NA and 'them' keep working to control and attack what they see as the opposition. The original plan of action still exists in the IB and minutes of Wichita.
- 2. FA 1 Wichita 260 members showed up. They were the cream of the crop the most informed members in the world at the time. Many were shocked to learn how much more was beyond their experience or informational base. They went home and constructed splinter groups that fit their level of understanding. The whole Fellowship benefitted because informal leaked out to more and more members.
- 3. Wichita Informational Booklet around 40 pages to inform attendance. Free download on core group NA.
- 4. Wichita FA 1 Minutes took 90 days to get minutes out. We still do not know reason for delay. Secretary posted they came out in three weeks. Free download on core group NA.
- 5. Disconnect gap between world services and Membership.
- 6. Kansas City Service Center planned but fell through. Planned central office in business incubator building with low cost and plenty of room to expand. Didn't do enough planning.
- 7. Jacksonville, Florida Global NA planned but fell through.
- 8. Grey Book with Stories well received by membership and first 100 copies distributed. Still attracting members interesting in having their own hard back copy. Cost of soft covers reduced to \$10.
- 9. Just for Tonight 400 quotations earmarked, many with essays. Calendar year developed and quotes assigned. Planning face to face to develop essays, daily prayer and thought for each day. First ninety days sent out to core group May 5<sup>th</sup>. Thanks Kermit and all who helped.

Lester – Fund could be in a separate account for books to go overseas.

Bo – Remember, the buyers pay for the fund. Some authors may want to keep price down. Again, having no blanket policy frees us to tailor each work to the wishes of the individual author. Local printing will circumvent high shipping costs to each Fellowship.


Lester – Drug ads on tv and magazines.

- 5. Disconnect The huge gap between world services and General Membership was discussed and we realized a stand-alone United States Service Conference (USSC) would not be possible until the Fellowship found ways to restructure NAWS. The only 'US and THEM' we had was between NA members and members of other fellowships who went to our meetings. When WSO got the big bucks, anyone who could them what to do was seen as an obstacle. It is not that they forgot they work for the Fellowship, they never saw it that way and no one had yet corrected them.
- 6. Kansas City Service Center planned but fell through. Planned central office in business incubator building with low cost and plenty of room to expand. Didn't do enough planning.
- 7. Jacksonville, Florida Global NA planned to hold a convention in Jacksonville but the plan fell through. We are grateful for the energy and attention brought to bear. The more we think, pray and meditate, the quicker things will get better.
- 8. Grey Book with Stories well received by membership and first 100 copies distributed. Still attracting members interesting in having their own hard back copy. Cost of soft covers reduced to \$10 since printer got more efficient equipment that lowers our cost. The Grey Book contains the early energy of the Fellowship where members were actually dying to have it written. So their spirit and devotion was evident in the work. Later editors stripped out things they didn't understand. This gives any member in the world a chance to get the real stuff for free. The quality really shows when read in a group setting.

#### From Dale A - Bangkok, Thailand -

Learned from Al-Anon that they refer to their literature as CAL and Non-CAL. CAL stands for Conference Approved Literature. Helped me realized NA has (in reality) categories of CAL, Non-CAL and WLCA (World Literature Conference Approved), WBAL (World Board Approved Literature, and NAWOA (NA Way Of Life Approved). Maybe further sub-categories of CAL might be helpful, such as the year the Conference Approved each specific piece of literature. Such as, CAL 1983. An example of WLCA literature is the Grey Review Form. All of these are (exclusively) NA Literature, written by addicts for addicts.

An example of Non-CAL would be AA or Al-Anon literature, the Christian bible, Buddhist literature, etc.

In reality, I think it's true to say, each NA Group chooses what literature it uses, and/or makes available at their NA meetings. Some NA Groups choose literature by Group Conscience, some by Consensus and others by various means such as a trusted leaders' decision, a committee, etc. That in itself can be confusing to some members and especially to newcomers. A statement that each group varies as to policy and literature might be helpful.

Another suggestion is a statement to the effect of; no NA Group would be effective using Non-CAL literature. One final suggestion would be a statement that reads, individual members and service committees are best served by NOT trying to enforce the unenforceable on NA Groups.

Still, more and more members are raising their heads up and looking around the NA landscape and are appalled by what they see. When the Fellowship no longer controls their practices and methods, they are no longer free. The membership has been co-opted. When you change yourself, you change the world.

Brian - Had my first NA meeting with John F. Drove up in Michael's Cadillac, we called it "Red Carpet Bottom." Went to 2 AA, CODA, 2 NA and one Debtors Anonymous, on a Saturday, I think.

Bo – How are the Teleconference Call Meetings going?

Brian – TC meetings struggling. Everything goes up and down, up and down.

Bo – like intercourse?

Brian – Come and go, some stay clean w/o NA.

Bo – Had a very startling thing happen at an NA meeting a few months back in Dawsonville, Georgia – up in the mountains. I walked over to meet some members sitting at a picnic table and one man stood up and said, "Marietta Bo." He was heavy set and had a beard. 40 years ago I got a 12 Step call late at night and this man wanted a ride home from the Greyhound Bus Station in Atlanta. He was emotionally distraught, so I wanted to help him. I was twenty miles away in Marietta, Georgia. I was nearly out of gas and my Oldsmobile Cutlass gulped gas. This was long before bank cards and so I had to go the night dispatcher at a nearby cab stand owned by a friend and ask her for some money to make a run to Atlanta. She was in a really bad mood and didn't want to be tricked! She asked how much I needed and I said, "Three or five bucks. I'll come by and give Bill the money back tomorrow." She pulled open a drawer at her desk and counted out slowly, 300 pennies. I just stood there. Finally, I got the coins and got three dollars' worth of gas and drove to the Atlanta Greyhound Station. I recognized the guy right off. He was real glad to see me! He got in the car and I asked where he lived. He said Stone Mountain. That was twenty miles east of us. So, I thought hell, twenty miles from Marietta, another twenty to take this guy home and thirty to drive home. Hey, God! I'm gonna run out of gas! But you know, I didn't. I drove him home and made it back to Marietta on 300 pennies of gas. Here he was in front of me, John from forty years ago. We hugged and sat beside one another in the NA meeting. I guess this is what they call the "X" factor. He had two years clean in NA.

Brian – Six of us rented a house together in California just north of San Francisco. Got to NA meetings with Lefty who had lost his right arm. He had gotten clean in prison and his parole officer made him to meetings in

San Jose. He later fell down some steps and broke his neck. We lived in Fairfield, California.

John – Yeah, Brian dug out the basement because when they built the house they left only six inches between the rafters and the dirt. Code required eighteen inches to rent out, so he made a hole in the kitchen floor and shoveled the dirt into buckets and dumped them outside. Took him two weeks but he got it done. He has a photographic memory. He knew all the Civil War generals I asked him to keep an eye on the car and when I got back outside, he had taken out his glass eye and had set it on the hood of the car!

Bo – When was this? What year?

John – Around 1983 or maybe 1987-88. We would go out on Highway 80 and help people who had flat tires. We had stuff to fix them.

Bo – Good Karma!

John – We could not abandon them. We had a friend in the Program who had a wrecker. Big John would give people free tows like fifty miles to their homes! One lady was late to a job interview. He gave her a ride. She tried to pay him and when he refused her money invited him to dinner! We were all doing stuff like that.

Bo – Y'all were grateful for recovery! We all were back then.

John – One lady went through all the men. She owned an appliance store. Doctor put her on meds.

Bo – Fellowship was kind and building NA!

Brian – In 1980 through 1989 – no questions when it came to helping others. Having a voice helps us go back to our authenticity. Just "go along:" with what others are doing cuts out some of the hope, dreams, personal authenticity. You become 'somebody.'

Bo – Up and down, right?

- 7. Jacksonville, Florida Global NA planned to hold a convention in Jacksonville but the plan fell through. We are grateful for the energy and attention brought to bear. The more we think, pray and meditate, the quicker things will get better.
- 8. Grey Book with Stories well received by membership and first 100 copies distributed. Still attracting members interesting in having their own hard back copy. ### Hello friends,

I have recently moved from Chicago 30 minutes south of Grand Rapids Michigan in August. I had gone to meetings and did a 30 and 30 in Grand Rapids. At my very first meeting I was greeted by young members that asked me if I'd like to join them in dinner. Mind you I'm 25 years old with six years clean. So I joined them for an evening after the meeting to Fellowship. I thought it was particularly odd because I noticed people that were with them that weren't in the meeting I'm sure they weren't in the meeting but where did they come from.

We arrived to the restaurant/bar. The guys that I notice that weren't in the NA meeting went to the bar. I

asked "who are those guys" one of the young members replied "oh they came with us after their AA meeting at the end of the same time" I "asked are they are friends" he responded "yeah, they like to sit at the bar and pick up chicks". At this point I was really surprised I couldn't believe what I heard. It was only later I'd find out that the person that invited me out to dinner was in fact a member of AA who only attended NA meetings to support his sponsee's. I asked him if that was really necessary given there were members of NA to sponsor these men. He replied "my sponsor told me to sponsor anybody who suffers" I asked him "is your sponsor Mother Teresa?" A few months later one of the first people I came to meet in Grand Rapids had died of an overdose and the day before he died of an overdose he got in a serious car accident with the sponsor speeding through traffic.

This was my first encounter with Grand Rapids NA and I wasn't particularly happy. From that 30 and 30 I made I would come to realize NA in Grand Rapids was very different. I had called a member and asked him to pick me up from my hotel I was staying at until I found an apartment that was where I resided. We galloped making no haste to the meeting. When we arrived we are greeted by another member who seem to have some serious disagreement with my ride. It was only after the meeting that I find out that they would try to fight. My ride was about 70 years old celebrating around three months clean and the man who wanted to fight was about 40 years old. I remember having to break the fight up and talk about the third step in the principles of our ever so needed third step. I was beginning to feel very upset with moving here and not doing too much research. I remember one meeting in particular it was a question and answer meeting and you pick someone who you wanted to answer a question. One of the questions I asked one of their old-timers about I believe it was the eighth tradition. He really didn't know what the tradition was until being reminded and not only that what he had to say but let's put it this way if it were me I'd be embarrassed having said so little. Fast-forward a bit and I would travel to Lansing pawpaw Kalamazoo Battle Creek Hastings Allegan and many more it almost felt like what I was beginning to see was getting worse and worse I can tell the difference between my attitude or the meetings it seemed all the same to tell you the truth. I called my vast network and asked if anybody had a good lead on any members of your with good recovery experience. Although I didn't find anyone I kept trying. Then I began to tell myself we needed a huge regional inventory we needed to come up with workgroups to solve these issues because it seemed like recovery was really nonexistent the only thing that existed was the desire to stop using but not to find a new way to live sure I believe some members wanted a little more than not using but I just couldn't hear it I just couldn't see it. Most of the information I was getting at this point with her step work and out of town and country phone calls. Nothing too out of the ordinary for

me but it was of lot more than I'd ever done it before I really had to supplement this lack of NA here. I decided I wanted to leave the Fellowship I shut my phone off and in return phone calls my sponsor and other members went looking for me. I began to realize that that wasn't going to work since I still wanted to talk to my NA friends I was just so upset with the Fellowship era didn't know what to do. Members had no concern whether they were involved in NA or AA it seemed all the same to them and now we seemed is the uptight and NA ass hole.

I met a friend named Paul G. he was my hope. I began to talk to Paul often and spend time with them. I was so glad he came when he did I do know what else I would do.

All the people that I enjoyed hangout with asked me to sponsor them. Which was a bummer because I was hoping there be more friends. I'm glad to help others but I also need a social network of my own outside the realms of sponsorship sponsee relations.

And where I'm at today I just recently come back after not making a meeting for a month. I left out a very important part I had a profound spiritual awakening as a result of the shock I had undergone. I don't think I would have experienced what I've experienced without having been introduced to the stimuli. I'm grateful to be a member of NA and want to carry a progressive message of NA a refined and potent one so that all can get what they need when I share when I express myself with others in a way just as much as I want the same from them.

### **Democratic Principles**

(Written at home of dear friend Johnny S. in Huntsville, Alabama June 2005.)

Everybody is somebody in NA. The reason why it is imperative that we embrace and actualize democratic principles stands out rather quickly when language is applied to the day to day reality we live within NA. We are very inbred, everybody knows everybody with a rumor and gossip system that would give us any type of information about another member that we might want, for any reason good or otherwise. We live in glass houses here. It is part of our recovery process to learn how other people actually live and deal with things that come up in their lives. So, participation, voting, is the way to keep it all above board. Everybody is in on it, everybody has a more or less equal chance to be informed, and everybody will abide by the vote, because it is fair. Even if the vote goes against our personal preference, we will go along and support it because it is part of our "agreement" that the others would have gone along with us had it gone the other way.

Now, this 'reality' is offensive and unwieldy to some and the 'some' found a way to get a better grip on things by changing our system of representatives to delegates. Now, there is talk of creating another 'layer' between the Regions of NA and the weakened World Service Conference. Maintenance of the appearance of participation from the Fellowship keeps the changes from being more blatant. Basically we have traded our interactive, participatory, spiritual service structure with something more like a religious board of deacons, a business like corporate board or a political government.

In the faces of a thousand silent witnesses, the claim is made that the Fellowship voted in the changes that have been made. No mention is made of the thousands of members who fled the world service system in NA when abuses came right and left in the early 1990's. This left a loose assemblage of members who had gotten clean only a few years before the 90's and had four or five years in 1991 or 1992. So, they really had no idea of what it was like before. The rest of the members who voted in changes were newly clean and took much on faith. They wanted to believe the leadership of the times and really, what else would they do? There were no study materials and the writings coming out in the Fellowship publications were captured as part of the takeover by the world board enthusiasts. So, the people who voted in the changes were acting after a good portion of the active Fellowship had been driven away be abuses of the system. It is sort of like serving sewer rat and blaming those who didn't want to stay for dinner. What is important to realize is that some of these members stayed in NA - and are still unaware of the exact nature of the changes. If you are somewhat informed on the subject, you are called 'disaffected member' since you don't go along with everything, ask questions and know about the changes.

The two opposing viewpoints are between efficiency and membership involvement: efficiency and involvement.

One idea is that you need to get a skilled team of members who are aware and experienced enough to make calls on behalf of the Fellowship with their best interests in mind. This would include consulting with certain members, creating a 'pool' of members who are ready and willing to jump in and form teams to do whatever they are asked. Funding, policy matters and procedures are arranged by the main board to expedite performance and get results quickly and at the lowest cost possible.

The other idea brought the Fellowship together in such great numbers and changed us from a small, almost insignificant program into a rather large and widespread Fellowship. It was based on democratic principles that make every member important by tallying their votes at the group, area, regional and world level. In other words, they get to approve/disapprove all decisions that affect the whole Fellowship. There is a feeling of importance that goes with this responsibility. Some decisions involve what is done, like where to hold a World Convention of NA. Other decisions involve how things are done in NA. These are called policy decisions. Policy is our Fellowship's standard reaction to things that come up repeatedly.

So, one approach would be to align all the gears and mechanisms and let members be the individual cogs that connect the gears. No one that important, everyone anonymous, all the machinery under control of a small, powerful group of people. Accountability and report systems are also under as much control as the others organs of publication. The other approach involves human beings who are much more than dead little sprockets of steel that stick up just so to mesh with other cogs to be part of a machine. Each of these human beings functions as part of a Program of recovery where all members are valued, important and informed so their participation is meaningful. Instead of steel, they have spirit. And it is the spirit that brings the whole thing together and makes it work.


Recovery is not the result of any machine. Each of us is held by our surrender and our heart strings. No one can tell us what to do and make it stick, if we don't want to. Our volition is very essential and important. If we stop believing in NA, NA will stop working for us or anybody else. Surely this is not privileged information. Nor is it merely personal opinion. To inform, involve and encourage NA members is our main purpose in NA.

Because of the unusual sequence of events surrounding the changes in our service structure in the 1990's, only a few members even realize the extent of the changes in our structure. Many members still refer to the Board of Trustees or sub-committees of the World Service Conference. While this is odd, it is also a key to understanding that one reason we have not suffered spiritual injury more than we have, is that no one knows. The changes were voted in after the exodus of members who were appalled at the length and deadening effect of the inventory conducted by world services to 'find out what the Fellowship wanted us to do.' In reality, the Fellowship knew very well what they wanted world services to do because it was written out in the approved service structure of NA. The practical advantage to all this is that we now have samples of how things can go wrong. Warnings of what would happen if we changes our basic structure fell on deaf ears. Ears that were interested in other things. WE actually have an obligation to honor and ennoble our members who do all these services for us in the name of NA by trusting them with the truth and informing them so that they really know what is going on and being done in their name. If this is seen as inefficient by some, let those few realize that we do not want only efficiency and business like traits in NA. NA did not start out to be a business or a publishing company. It started out as a self-help organization that followed 12 Steps and 12 Traditions for personal recovery and to help others where ever possible.

I want to go on record as predicting that everything will turn out alright. But it will take a measure of commitment from many members if it is to be so. We have to be firm in our input to world services that our service structure reflect the reality of democratic principles not so that time and money are wasted but so that members are in on things that affect them. There is a belief afoot that the end justifies the means. Well, in our case, the best of intentions fail the most important and basic test if NA members don't know and feel good about what is happening. Advocating open communications in this maelstrom is no easy chore but there must come a time when members say, "Enough!" and we get back to building our Fellowship into all it can be. Nobody I know wants a bad business office but just the same, no one wants a business office that is aggressive at the expense of our members. The situation now is so far gone that even a 'vote' at the world lever lacks the solidity of a motion know, understood and really supported by the general membership. It is likely that we will rejuvenate somehow from the members and groups down the structure links to something like world services. I say like world services because it may not be apparent what is happening at first.

We now live in the information age. It is now possible to ask questions and make comments without going through a structural procedure that brought members of good will together in service settings where all were able to speak, ask questions and get answers. Today, we have other way of getting answers. There are many changes. Members get files, records, court reports, information on the history of NA and have access that just was not possible until the last few years. I have seen the members of this Fellowship consider a situation for quite some times and then take decisive action in a quiet but effective manner. I remember one time like this when every member in metro Atlanta said the words, "I am an addict and a \_\_\_\_." Then, one night with no discussion I was aware of, no plan and no coercion, everyone in the room said, "My name is \_\_\_\_, and I am an addict." It was really something. A quantum jump from a loose, random identification to a meaningful, real and accurate single term that identifies the say as a person who freely admits their addiction and their need for help. This is what makes them a member of NA and different from addicts who cannot make this admission. This is what we find admirable and why we call the newcomer the most important person in the room at an NA meeting.

I remember back when the general Fellowship had an open attitude to an early version of "it Works" and then they began reading the material in group settings to evaluate it for general approval as it a piece of NA literature. Certain word choices came up and it turned out they offended every member present. The material failed approval at so many groups, areas and regions that it failed approval at the World Service Conference. Of course, the time and money spent on the project was wasted but it was more important that members agree to approve the material as accurate as to our NA recovery process and experience. Pushing through material without sufficient Fellowship review is dangerous to our Program because errors that could have been corrected are typeset into 'official' approved writings with our NA name on them. It is evident from our subsequent history that there were those who thought the loss of time and money was more important and they took measures to change our approval process.

Our good name was earned by intensive Fellowship reading, discussion and review. Where approval no longer means that the writing has been subjected to such intense study, and close scrutiny, it can hardly be expected to have the same power to speak from the heart in a way that makes the reader wonder to see their experience and feelings in print. We owe it to ourselves to become informed and effective in our understanding of the principles that can have such a devastating effect on our validity and actualization as a spiritual Fellowship. Society will always come up with new, non-addictive drugs for us to take and in our weakness as addicts, many will be drawn once again into their dependence on chemicals.

This is compounded since some people really do require chemicals to live relatively normal lives. These people need their medication the way the rest of us need food and air. It is up to each individual member to make this important decision. But a few common denominators are clear. AS addict in active addiction cannot take their medication as prescribed by an informed physician\n. They will always take more or less. This is because of the \obsessive/compulsive nature of our disease. Second, for a person who needs medication, it is using for them to not take their medicine. To not take it makes changes that are life limiting and life threatening. We never tell someone new to go off all prescribed medications because it can trigger physical and psychological reactions we cannot possibly know about. Original NA dealt with illegal drugs traded in the streets or at least in secret because of the illegality. Time and our success in those areas has forced us to consider other questions. Like medicines prescribed for extreme physical pain, these medications do not trigger the compulsive/obsessive reaction that characterizes our disease. No one can cheat and get away with it. If they are not taking 'real medication' for an illness, their disease will accelerate at some point and a relapse will follow. Sometimes quickly, sometimes over a period of time. But no addict is exempt from relapse, by definition.

Again, it is our common welfare that is at stake. Our membership includes a broad range of addicts from prescription drug abusers to street addicts. We have member who are wealthy and well educated alongside members who never finished their education. It is difficult to generalize among all of them for those things that can be said to be true for all of us. But our desire for recovery unites us. The 12 Steps work for us in ways that we find incredible and wondrous. Our recovery leads each of us to a place and time in our lives when things finally begin to make sense and our understanding grows to the point of personal peace and acceptance. Peace and happiness begin to dominate our lives. — Bo S/



The fact is there is another version, and that's what the folks that are printing it believe is true just as passionately as the version the WB and NAWS believe is true. I tried to offer some additional information on the history and was repeatedly shut down by the WB members leading the breakout group. It was very frustrating. I gained a huge amount of respect for Steve R when one AD referred to the members printing the Baby Blue as "assholes" when Steve R reminded us that they were members just as passionate in their love for NA as anyone of us. When one AD said that he'd like to hear what I wanted to say so they had all the information they needed, the WB member lead the group told them they had already been given all the information they needed. I lost my temper and said something I regret and walked out. We can't make an informed decision unless we have all the information and I'm sorry but until we start getting more than just what the WB wants us to have, there will never be an informed fellowship decision on the FIPT. Questions are formed by the WB to elicit a prescribed response. All the questions we did straw polls on where formed that way. We're we led like sheep? And frankly Carlos, I'm offended that you talk of profiteering in your post when no one I'm aware of us profiteering off those books. Maybe it's happening in Brazil but not in the US. I sure hope that is the information you're giving your groups because it's false. ---End Quote---John, I was talking about the experience we have here: and that is all that I can offer, my experience. This is that some outside enterprises copy the BT and other pieces to sell to potential future NA members under their care. And there is of course the individual member who wants to produce merchandise for their personal profit. That is what our experience is and that is what we sought solutions for. Ok, I see the point you make, you want to have another edition of the Basic Text distributed, non-profit, to carry the message. Well, I just don't agree that other editions of the Basic Text should be used to carry the message. And I believe that the Fellowship here wants that to be so: that NA groups use only NA approved literature. There might be some resistance here about using the 6th Edition of the Basic Text, since our 5th Edition was an incomplete version without any personal stories. But all I can tell you is that those who are voicing that opinion have not yet read the 6th Edition: and we made a full revision of it, the whole lot is revised to a better translation. So, people who read the text really agree that it is a very good piece of literature. The issue of the cost of the book is being accepted, and we are starting to use the White Booklet and the Introductory Guide as give away to newcomers (yes, we do give away a book to any newcomer, and we were used to giving out the old Basic Text, now we are starting to change that policy in the meetings as the stock of old 5th edition ones start to run out). So, no, John, I'm not communicating any wrong information, I am stating the facts as they are; that there are many members, in several places, who feel strongly that they should use other editions of the Basic Text in their meetings. But that is only part of the FIPT discussion. Ok, you feel that there needs to be more discussion on the topic, and I hear you on that. Sure, if something is not discussed, then the minority is not heard, and we should do that, listen to your point of view on the floor, sure, I hear you. But there is something that I don't understand: are you in favor of changing the FIPT to accommodate just that issue of groups using other editions of the BT, or do you reject the whole FIPT and believe something else should be put in place? \* Hello, Tristate Adam has just posted in the WSC 2016 forum of WSC Participants Discussion Area (rev2012) under the title of Illicit Literature: Is there a path to Unity? I also understand why some groups print the 2nd and 5th Editions. I don't support removing websites because they offer our current literature for download for free but I have multiple reasons for that including a selfish one: local area websites list the most reliable meeting locales and I travel a great deal and sometimes, I can get in a bad space and really need a meeting. God help any one of us that needs a meeting and can't find it because of political nonsense. Removing them also hinders those that are trying to find us and could end up being a death sentence for them. One of the things that came out of the lawsuit over the BB was a federal judge telling NA, all of us, they needed to grow up and work out our differences. That struck me when I heard that and for me I believe there is always a way to do just that. Here it is almost 30 years later and we still haven't been able to figure out how to do that. I believe that we have to find ways to compromise and that is what we seem not to be able to do. When I first got clean, several years before I found NA, I had a sponsor that taught me that group conscience and group majority are not the same thing. When we form true conscience we take into account what's best for us all and find ways to set our differences aside and do what's right for us all including those yet to find us. I fail to see how the infighting over literature and money, yes, free literature is about money, like it or not, doesn't serve any of us well. It surely doesn't serve those yet to find us or our 5th Tradition. There is a solution in here somewhere. We're not going to find it though by getting 1/2 truths and one sided information. We need to have all the information. Votes at the WSC don't make fellowship conscience. Fellowship conscience lies in doing what's right and lies in the heart. I have no doubt you are just as passionate in your beliefs as I am in mine, brother, but what about those whose lives hang in the balance of us digging in our heels and refusing to move? This is just my opinion here, but right now NA is in the middle of the biggest divide or crisis of disunity I've ever seen in the over 35 years I've been around here. I walked away from service once because of what I saw but I'm not going to do it again. There is a solution to all this that doesn't require us to continue the divide or isolate each other. We all just need to have a little willingness and compassion to work hard to find it. I have to be honest and recognize that, outside NA, I go for the websites that have free academic literature and books to do my work - shame on me. I don't consider it piracy, because I'm not using those copies for my profit. I am grateful that there are people who share their copies of things, so that I can have access to a material that I would otherwise have no access to. That being said, I was just sharing with you what the general feeling around my region is: that only Fellowship Approved literature should be used in NA meetings. I stand by that. Now, the solution of having the draft of the First Edition being published as a historical piece seems to be a good one, with a disclaimer, sure. What I really don't understand is why John thinks that we are dealing with half-truths on this matter. My first contact with the different books movement was back in 1996, when someone handed me a diskette full of different texts, asking me to give out copies to all Latin-Americans (which I never did). Since then, I occasionally look up different sites - out of curiosity, and I have read part of the Traditions Wars book, etc. - I find that material, though interesting, really not suitable to carry our message, for several reasons. I have never had the opportunity of having a Grey book in my hands to quote it comparing with the 6th edition, but I have information that some crucial passages are different. If the Basic Text has been approved in its most current version, I just can't understand why this has to be an issue. Is the addict who is walking into our rooms really going to miss something if that other versions of the Basic Text aren't available? Or he or she will have the full message available on the table of the rooms with our current catalog of literature available? Now, you, John, say that you don't remember the FIPT being approved by the WSC - well, I remember it being, so now both of us need to go back to the minutes and reports to see who remembers it correctly. When I came to the rooms, in 1990, we had a Basic Text here in Brazil that was the translation of the First Edition with some changes, it had no Recovery and Relapse chapter, no personal stories, and the name of the Fellowship was translated differently. That old Basic Text carried the NA message to me. But when I had access to the 5th edition (I actually took part in the efforts of translating and reviewing it), I saw that it had a much clearer message, so I never got attached to that old text. Some guys here have copies of those older versions of the BT, and we regard it as a curiosity, some object to cherish as part of our history, not something to be read as part of our personal recoveries. It tells our history, but it isn't our current BT.I don't feel passionate about it, but I also don't really see what the point is. Can you please clarify to me why should we in any way change the document that protects us from the wrong uses of our property (such as those that I have mentioned that do affect my community, and that you Sandy say that are a different matter)? Why is it so important for those who advocate having a different edition of the Basic Text feel this is so important? And yes, I do feel matters of money are important. It was NAWS money that paid for literature and keytags to be sent to Rio de Janeiro and Brazil in the early 1990s - we didn't have the means to pay for it, so NAWS sent it for free first. Then we started to pay for the freight, then for part of it, then a larger part, until we were able to pay for it in full. Now, roughly 25 years later, Brazil is 10% of the sales of literature in NA guess what? We do feel matters of money and receiving money for the literature are important. So, it isn't a matter to be taken lightly. Today, in Brazil, a Basic Text costs around 9 dollars to the member, but there are other places of the World where it can cost 20, 30 up to 40 dollars (and their socio-economic reality is not measured in US dollars). Where is the money to subsidize that message being carried coming from if we are going to give our literature for free? If we can agree on those basic principles, then we can reach some middle term. #### From Conference Calls during the development of the FIPT Document...

More from the FIPT Formation conference call... (Pasted in from FB.)

The '81 literature committee and those four conferences were something that happened in the fellowship, was a phenomenon that didn't have a precedent and hasn't happened since. The members that worked there, and the fellowship that they were representative of developed a trust bond with the service structure that the results of their work would be used in the same spirit and manner that the work was developed. This must be, in my opinion, the foundation and the basis of this literature trust document.

BS: Roughly, I agree.

GD: I agree. The fellowship and the people who wrote and participated are actually the authors and the owners. I think you've got it switched around. I didn't send any input because I've got some minutes of the conference here, it says to me that the things that we had discussed in Harrisburg and other times, and the promises that were made to Jim and Kathleen and Bo and myself and others that were present at the time, were ignored. It's like you've got the exclusive rights to do whatever you want to do as far as I'm concerned, it seems like that is "your" trust. The trust that I had that you wouldn't ask for these things and you wouldn't do the things that you have done, you violated that trust.

ST: I never said that we wouldn't ask for it. I put it in the Conference Agenda Report. That's not true, Dave. I told you I was going to ask for it.

JM: What I understand, Stu, what I remember was that in those documents that you gave us your assurance that you would share that something was in process, and that after the process was completed, that you would ask for this, and mention that in any requests for it. I felt you made yourself very clear and agree substantially with Dave.

ST: No. What I agreed to was the fact that I would ask for this in lieu of producing any other document. I agreed that this document was premature to distribute at the conference at that time. It needed some work. I instructed the conference that we would be working on this document and would send it out.\*\*\*



BS: It's eight hours long?

U: The whole thing was.

GD: If you could get those copies and send them out, then we would have a better idea of what the conference felt like, and what they wanted. If you want me to at least modify my feelings at this trust, then that would go a long way. I don't like to operate from a position where I've got no information. I don't like to make a mistake or get something wrong. It sounded like there was something that could come out of all of it that we would all be happy and satisfied with, and there were things discussed at that time. One of those things was that three months after the conference, when we should take and put out the trust document. That was one item. The second item was the idea of exclusivity and ownership of the properties. You would have the exclusive

#### Summary:

I am not alone in noting what appear to be gross differences in the NAWS, Inc. bylaws that qualify them for non-profit status and their actual fiscal practices. We think that these deliberate misleading actions constitute fraud upon the State of California. We are pressing for a forensic audit by the State.

Salaries: Executive Director's salary on his 2014 tax return is \$251,936.00 before benefits. The Executive Director and his assistant's salaries increased by \$150,000.00 in one year.

Conflict of Interest: Some NAWS members sit on the Boards of outside rehab programs. Example: Executive Director of NAWS, INC. Anthony Edmondson serves as Treasurer of the Board of Directors of Cri Help, Inc., a California drug treatment facility.

NAWS bylaws state they are restricted by the 12 Traditions of Narcotics Anonymous (not the 12 Concepts later devised by NAWS, Inc.). Selling to outside enterprises for profit such as Amazon, Hazeldon, Sears would seem to not only violate their trustee position but would place them into a "for profit" category. Much NAWS income today comes from publishing.

Example: Basic Text costs approx. \$2.30 to produce but is sold at \$11.55 a 485% markup. Certainly profitable.

Misuse of funds: 1) Fellowship funds were used to litigate against a member for providing free literature. The court found in favor of the member and a court order was issued which NAWS is in violation of to this day. NAWS is extorting groups who do not use NAWS published literature by refusing to list them as NA groups and lately advising other members to seize "illicit publications" and sending out "Cease and Desist" letters. 2) Massive losses of approx. \$900,000.00 in back to back conventions. 3) Annual Rent: \$7000.00 per month in the highest Real Estate market in the U.S. 4) Other Costs: \$105,360.00 not explained. 7) Excessive travel by NAWS which is unnecessary in this time of advanced communication technology 6) 1st class transportation, single occupancy accommodations for World Board members. 7) Frivolous spending: Afternoons at "The Ranch" for NAWS people cost approx. \$28,000.00 each time. 8) Theft of funds from a literature warehouse in Russia unaccounted for to date.

Violation of the Anonymity Principle: NAWS disclosed members' names and addresses to the NAWS law firm. This is a serious breach of Traditions and of individual privacy rights.
