NOTES ON INTERIM DECISIONS

TRAVEL

Italy: The original mention of a trip to Italy gave February/March as the possible date. We have since received information that the Italians are requesting a service structure/translations workshop in May.

Mexico: The Mexicans have since informed us of their dates for a workshop in Mexico City, February 5th and 6th. In our letter to them for their invitation to the WSC we implied our support and attendance at such a meeting. A short visit to Panama should also be considered at this time for the WSO research on Latin American distribution and production of literature.

NOTABLE ASSUMPTIONS

We are assuming of course that the routine expenditures such as the quarterly administrative expenses, Conference and Development Forum fund, Reaching Out, H&I literature stockpile, etc., are continued.
